WIDER INTEREST IS IN EVIDENCE

Large Audience Heard Earnest Speeches by Workers of Child Welfare Society.

The meeting which was held yesterday afternoon in the Y. M. C. A. auditorium, under the auspices of the Child's Welfare Society, to acquaint the people with the necessity for a reformatory, children's playgrounds, etc., was well attended by both men and women. An interesting program had been arranged and there were several talks by those actively interested. Music was rendered by the Boys' orchestra and by a quartet composed of Dr. L. B. McBrayer, J. G. Stikleather, C. T. Carr and Frank Smith. Mayor Rankin presided over the meeting. Dr. R. F. Campbell offered the opening prayer and there were addresses by Zeb. F. Curtis, Dr. L. B. McBrayer, Dr. C. W. Byrd, Judge J. G. Adams, and Mrs. C. W. Johnson.

Mayor Rankin in his opening remarks, called attention to the necessity of providing some means, by which the wayward youth of the town and county can be controlled. He spoke in praise of the work being done by the probation officer but expressed the opinion that the children should have the proper legal as well as moral restraint. He said that the laws allow any city to establish a reformatory and that it is better to spend the taxes in this way than to be forced to spend it for penal restraint. He expressed pleasure at the strength of the movement in the city.

Zeb F. Curtis spoke on the "Value of the Child to the Community." Mr. Curtis said that the object of the Child's Welfare Society is the uplifting of the children, to help the rich and the poor and push the establishment of the reformatory. He considered the child a commercial asset and a conservator of society. In reviewing the work that is being done for the moral welfare of the children in the state, he said that this phase of child management is not being considered as seriously as it should be by the state officials. He thought that Asheville can have a playground of any small cost.

Mrs. C. W. Johnson told of the marvelous work that is being done in the city of Baltimore through the public playground where the children indulge in healthful sports under proper direction.

Judge Adams made an excellent talk on "Child Criminality and Reformation." Though the question has been an obscure one heretofore, he stated, it looks as though there are to be results from the discussion that is going on. The reasons for child criminality he gave as home influence, influences in their daily life and the crudeness of the law as applied to them. He also spoke of the need of a reform school.

"The Stuff a Man's Made Of" was the subject on which Dr. McBrayer spoke. He declared the mothers should co-operate in the movement for the playground and reform school and stressed the moral, mental and physical needs of the city's children.

On the subject, "What Shall We Do About It?" Dr. C. W. Byrd began by expressing gratification at the interest that the city officials are taking in the creation of a reform school and emphasized the good the playground will do. He told of his visit to the training school at Concord, declaring that Asheville needs such an institution.

Dr. Byrd pronounced the benediction after which the meeting adjourned.

After the meeting was adjourned about 25 members were added to the roll of the Child's Welfare Society. There was evidence that the people, who attended the meeting, were much impressed with the need of these two institutions and that they will strongly co-operate with the influences which are working for their establishment.

CITY NEWS

There will be a meeting of the Y. M. C. A. directors tomorrow evening at 6:30 o'clock, at which the winter work is to be considered.

Deputy Collector Nitzer reports the seizure of an illicit distillery in Transylvania county and Special Employee J. L. Sams reports one seizure in Graham county.

The recent statement of the Blue Ridge Building and Loan association shows that the institution is having a steady growth. The fourth series of stock, amounting to \$26,000, is now being paid off.

There will be an important meeting of the board of directors of the Young Women's Christian Association at the Henrietta, tomorrow morning at 10:30 and all members are requested to be present if possible.

Harry S. Burrows, who held a position with J. C. Wilbur for several years, has accepted a position with the American Tailors on Patton avenue and his friends may find him there in the future.

Tomorrow Judge Pritchard will hear arguments of counsel for the petitioners in the matter of Richlands Coal company, bankrupt. This matter comes to the Circuit court from the western district of Virginia.

A capias was issued by the clerk of the clerk of the court Saturday for Paul Altman, who is under sentence of eight months on the county roads, for failure to make appeal bond. It is said, however, that he was given 30 days additional to perfect the bond.

Lawson Daugherty, charged with the killing of Milton Hamby at Black Mountain about 12 years ago, who has been in the county jail for several days, today arranged for bond of \$4000 and was released from jail.

A number of salespeople have been engaged by J. W. Nichols, receiver of the bankrupt Kindley stock of goods, and preparations are today being made to arrange the goods for the sale, which is to begin tomorrow.

Friends of Tolle Miller, who was a native of Buncombe county but a late resident of Clay county, where he taught school, were grieved to learn of his recent death after a short illness. Mr. Miller was born near Juno. Surviving are the widow and three children.

The officers of the Western North Carolina Fair association are now considering the appointment of the marshals for the fair this fall. They have appointed L. E. Ferry of the Mills river section as the chief. It is expected that he will come to the city in a few days to confer with the officers with respect to his duties.

The Asheville Ministers' association will hold its regular monthly meeting tomorrow morning at 11 o'clock in Dr. Byrd's study. Secretary Ed. B. Brown of the Y. M. C. A. will be the speaker for the occasion. His subject will be, "Working Together—the Churches and the Association." All visiting ministers are invited to attend.

In an effort to have a good attendance at the convention of the North Carolina Postmasters association, which meets here September 19, Secretary Buckner is sending out Asheville booklets to all the postmasters in the state. He is also getting up a list of the conventions that are to meet here and is sending the booklets to the members of the various organizations.

Requisition papers for the removal of Ben Owenby, colored, to Allendale, S. C., were received several days ago by the authorities at that place from Governor E. C. Ruffin and Judge Sheriff F. P. of Barnwell county came to Asheville for the prisoner. Owenby was arrested here August 20 for the charge of larceny, and had been held in city jail since that time pending the negotiation of requisition papers.

Judge Adams had a vast variety of cases to dispose of in police court this morning but none were of very serious nature. There were a number of "drunks," a few disorderly conduct cases and various others. The heaviest fine was imposed on James Kilpatrick, which was \$50 for cruelty to animals. No road or jail sentences were given. A half dozen small boys, charged with throwing rocks at the house of Tom Stewart, will be tried in a juvenile session of the court this afternoon.
