The verdict is looked to with pecuhar interest, in connection with the next Presidential election. It will be seen that the returns have come in more favorable to the Democrats than the first news

Louisiana.

The Democrats have carried their entire ticket for State officers in Louisiana. Robert C. Wickliffe is the Governor elect. The successful candidates for Congress are George Eutis, Jr., Miles Taylor, Thos. G. Davidson, and John M. Sandidge, the three last leing Democrats. The Know Nothings have a majority of about 250 in the city of New Orleans, while the Democrats have about two thousand majurity in the State. The Legislature is also Demoarotic.

The Know Nothing majority in this State is only 2.635. Bowie an I Stewart, (Democrats,) and Ricaud, Davis, Harris, and Hoffman, (K. N.'s,) are elected to Congress. Mr. Vansaut, (Dem.,) will contest the election of Harris, on account of foul play in the 3d Ward of Baltimore, where there were 51 more ballots than there were names registered.

Mississippi.

The Democratic majority in this State is about 5 000. It is believed that the Democrats have made a clean sweep, and elected the entire delegation to Congress. The Know Nothings claim the election of one out of the five. The Legislature is Democratic by 30 majority.

New Jersey,

-----Foreign Relations.

The Washington correspondent of the N. Y. Commercial writes:

"The Administration here do not represent that the British government has assumed a hostile aspect against us. They do say that it has acted in manner that is ungenerous, and tending toward a difficulty. It is possible that foreign questions may assume an aspect of such importance that the domestic questions concerning Kansas, slavery, &c., will be absorbed or superceded, in the consideration of the next Congress."

If the last conj cture is realized, the country will have no cause for regret. Even if a foreign war be the result, it might be the means of saving the Union.

KANSAS TROUBLES-FATAL AFFRAY. - The St. Louis Republican has the following additional particulars relating to the recent attempt to kill Pat. Laughlin, at Doniphan, Kansas territory, on the morning of the 31st ult :

On that day Samuel Collins, who was, it seems, Colonel of one of the regiments of the "Kansas Legion," an exposition of which had been made by Mr. Laughlin, determined to force him to make a retraction, or to kill him. With this determination, he and some twelve other of his friends proceeded to seek out Mr. Laughlin and demanded an unqualified retruction of his recent statements. This he refused to do, and Collins immediately snapped his gun at him, but fortunately the weapon was turned aside by a spectator. Laughlin then drew a revolver and shot and killed him. Mr. L. was dangerously hurt in the conflict by a knife wound in the side. At the same time, Mr. Lynch, a friend of his, was wounded in the head by the discharge of a gun.
