The longest road is the New York Central, 556 miles; total cost and equipment thirty millions, and last dividend eight per cent. The shortest is the Erie and North-cast, 20 miles; cost and equipment seven hundred and fifty thousand, and last dividend 10 per cent. The largest dividend is made by the Galena and Chicago road, and the smallest by the Raleigh and Gaston. It therefore appears from this statement (abbreviated from the American Railroad Journal May 22) that ninetyfour completed roads make no dividend at all. Of the whole number, only eight have not contracted debts. The debts are enormous, the lowest \$8,242, and the highest \$2,081,468; and it also appears For the sale of Cotton, Grain, Flour, and all kinds of that twenty of the companies have borrowed the round sum of two hundred millions of dollars.
