RALLIGH, September 28, 1859.

The President and Directors of the Literary Fund, having made distribution of the net income of said Fund for the year 1859, among the several Counties of the State for Common Schools, have directed the following Tabular Statement to be published, showing the Spring and Fall distribution to each County, and the total distribution during the year.

The amount of the Fall Distribution will be paid to the persons entitled to the same, upon application to the Treasury Department.

Jackson County will receive 30 per cent, of the amount allotted to Macon county, and the remainder of its share from that allotted to Haywood. Alleghany, Madison and Polk will receive their respective shares from the Counties from which they were formed, there having been no report of the population from said Counties.




