

MOBILE, Sept. 19th .- The Dog River Cotton Factory, near this city, accidentally took fire on yesterday and was destroyed. The loss is about \$100,000, but insurance covers \$42,000,

SEIZURE OF BACON AND LEATHER .- We understand that in compliance with the Proclamation of ble to the Regiment, and deservedly popular with all the Governor, a large quantity of Bacon and Leather, en route for Virginia, and the property of speculators, was seized at the Depot of the North Carolina Railroad in this city on Wednesday. We hear, also, that a quantity of Bacon bought on speculation, and destined for a point out of the State, has been seized at High Point.

Speaking of speculators, we are constrained to say that glaring attempts at monopolizing the article of bacon have been made in this quarter. One concern, composed of two individuals not engaged in mercantile business and paying no merchant's license, markably well. Chills and fevers have so displayed have bought a large quantity of Bacon at 18 cents themselves upon my lips, that it is with difficulty I can or less per pound, and are selling it at 25 cents.
