COTTON SAW GINS. Straight RIBS vs. Crooked. Uniformity of Roll, &c.

ALTHOUGH the advantage of the straight rib in the COTTON GIN has not been discovered more than twenty years yet it has not been sufficiently known or appreciated by the planter. The advantage consists simply in this: that the straight rib can be moved down to where they are not worn, which answers the purpose of a new set of ribs. Three moves can be made, which gives four wearings, which is equal to four sets of ribs. So that the extra cost of the straight rib, which would be equal to the cost of a new set of ribs, is nearly paid for by the extra wear of the straight rib.
