From Northern Virginia

The recent movements of our forces have led to the impression in some quarters that the entire evacuation of Northern Virginia was designed, or that these movements were made with reference to the reported advance of the enemy under McClellan, through Loudoun county. Our own information on the subject, derived from quarters deemed reliable, leads us to believe that the change of position recently made by our army was effected without regard to either of the contingencies above referred to.

From Winchester, and the country below, we have private advices as late as Thursday morning. No movement of the enemy had taken place up to that date along the upper Potomac. As Harper's Ferry, Shepherdstown, and Williamsport, all was quiet, not withstanding the boast of Northern correspondents that their forces would occupy Winchester before the close of the week.

News from Jackson's Army.

KNOXVILLE, Oct. 29.—The Lynchburg Republican, of the 28th, contains a letter from Stonewall Jackson's army, dated Banker Hill, October 29th, which confirms the reported destruction of a large portion of the Baltimore and Ohio Railroad. Thirty miles of track were destroyed, reaching within three miles of Harper's Ferry; also many valuable buildings belonging to the company. The Abolitionists are still in strength at Harper's Ferry. Our pickets are within five miles of that place, and on the Potomac, opposite Williamsport, Md.; also, at Shepherdstown, Virginia.
