Mr. Frank Parker, an old citizen and a good man, aged about 74 years, died at his home at the Eno Cotton Mills last Friday, after being six about sick days with pneumonia. He was buried Saturday afternoon at New Sharon.

### LITTLE BOY DROWNED.

Cary, the little 5 1/2-year-old son of Mr. E. H. Spivey, fell in the fall race at Fayette's old mill last Saturday morning, about 4 miles northwest of Hillsboro, and was drowned. It seems that the little fellow who was standing on a small bridge over the race, measuring the depth of the water with a long stick, and falling over headlong into the water he was carried down into Eno river. A little brother saw him when he fell into the water and gave the alarm. The river was searched by the neighbors from

Saturday morning at 11 o'clock until Sunday afternoon at 3 o'clock when the body of the child was found in the river about one mile below the place he fell in. The Observer desires to extend sincere sympathy to the distressed parents.

### From the Chapel Hill News.

Died, Miss Susie Neal, aged about 35 years, of consumption, at her home in Mt. Gilead church neighborhood, on 14th inst.

Died, Mrs. Williams, in Mt. Pleasant church neighborhood, on 15th inst., of pneumonia. She was the wife of Mr. E. Williams.

Died, Miss Nancy Johnson, aged 44 years, at her home in Mt. Gilead church neighborhood, on 12th inst., of pneumonia.

We learn that Mr. John T. Hogan, who last week was found on the road between his home and University Station in a helpless condition, suffering from a stroke of paralysis and cold, is getting on very nicely and that there are now every hope for his recovery.

Mrs. Lloyd, wife of Mr. Merritt Lloyd, died at her home in Lystra church neighborhood on 13th inst. Mrs. Lloyd had been an invalid for over twenty years. Deceased was well known here, having lived in Chapel Hill for a number of years. The remains were interred at Lystra on Saturday last.

Died, Mrs. Hackney, wife of Mr. J. H. Hackney, at her home two and a half miles south of Chapel Hill, on the 13th inst., about 3 o'clock. The remains were buried at the Cole family burying ground on Friday evening. Rev. W. R. Royall conducted the funeral and burial services. She was a consistent member of the M. E. church here. The announcement of her death was quite a shock to her many friends and relatives. She leaves a devoted husband, four small children, a father and mother, besides a host of relatives and friends who deeply mourn her untimely departure. She was a daughter of Mr. and Mrs. W. F. Cole, near town. The family have the sympathy of the whole community.

### J. C. Yates Bound Over.

In magistrates court this week J. C. Yates, who conducts a store in East Durham, was charged with selling whiskey. After the matter had been considered he was bound over to the superior court under a bond of \$200, which he gave and was released.

In the trial Mr. Bryant, who appeared for Mr. Yates, asked that as he was bound over once for the same offense, upon the testimony of the same witness, he be discharged. This was refused and both cases will come up in the superior court.

## DEATH, THE REAPER, AT WORK.

From Many Causes Both Old and Young Answer the Summons.

That all must die is evident at all times, but is more forcibly brought to mind when many are called at one time. Such has been the case in Durham during the past week or so. Some have gone after a lingering, while others have died almost suddenly:

### ALBERT M. CRAIG.

A young man, enjoying all the blessings of health and friends and relatives last Saturday, today lies buried in Maplewood cemetery. Albert M. Craig, aged 20 years, died at Watts Hospital last Tuesday afternoon. Last Saturday Mr. Craig complained of being ill, and a physician was summoned. The attending physician soon discovered that he was suffering with appendicitis. He was carried to Watts Hospital and an operation was soon decided upon. Monday the operation was performed, which disclosed the fact that it was too late to do much good. From that time he grew worse until death claimed him as mentioned above. Mr. Craig was a young man whom everybody liked that came in contact with him, and as he was conductor on the street car he naturally had many friends. He leaves four sisters and four brothers. The interment took place Wednesday afternoon in Maplewood cemetery, the funeral being conducted by Rev. E. R. Leyburn.

### MRS. MARY M. TILLEY.

Mrs. Mary M. Tilley, aged 68 years, died at her home in Lebanon township last Tuesday morning at 8 o'clock. Meningitis was the cause of her death, and she leaves a husband and five children, two sons and three daughters, Mrs. N. E. Couch, and Mrs. N. A. Holloway, of Durham, and Mrs. John L. Scott, who resides near Rose of Sharon Church. Her sons are J. L. and S. G. Tilley, who live near the home place.

The burial took place at Mt. Lebanon Church at 2 o'clock Thursday afternoon.

### MRS. LOULA GRIFFES.

Mrs. Loula Griffes, aged 65 years, died at Watts hospital this morning at 1:30 o'clock. Mrs. Griffes has been living with her daughter, Mrs. Daisy May, on Walker street until she was carried to the Watts hospital several days ago.

Severe cold was the cause of her death and she was apparently getting along well until midnight last night when she was suddenly taken worse and soon expired.

### Mrs. Thomas Summoned.

Thursday Mrs. Octa D. Thomas, who has suits against seven Durham merchants, was summoned to answer some questions relative to the claim against them. There was some irregularity and the matter was set for a hearing on the 26th of this month.

This summons is connected with the case Mrs. Thomas has now in the superior court for damage against Durham merchants for seizing her household effects while she was in Baltimore. Three cases are set for a hearing at the March term of Durham superior court for the trial of civil cases.

An entertainment will be given at Patrick Henry Institute tomorrow. Exercises by the children will be followed by a "Cake Vote," the proceeds to be used for improvements around the school.

Barrett, pastor of the Second Baptist church, officiating. It was a home wedding and quite a number of friends were present. After the ceremony had been performed the happy young couple left for a few days' visit to relatives of the groom in Orange county.

Thursday evening at the home of F. C. Geer, in the presence of relatives and a few friends, Miss Clara Tatum, a niece of Mr. Geer, was united in marriage to Mr. R. L. Bellamy. The ceremony was performed by Rev. C. J. Thompson, pastor of the First Baptist church. This young couple have many friends in Durham that will wish for them all the joys of this life. They will make their home in Durham.

Miss Grace Lois Edwards was united in marriage to Mr. Robert Fulton Perry at the home of Miss Edwards. Rev. C. J. Thompson performed the ceremony. Mr. and Mrs. Perry are well known in the city and county and have many friends that will congratulate them. They have taken rooms at the home of O. M. Perry, where they will reside for the present.

## Found Dead.

Chapel Hill, Feb. 19.—Miss Mamie Wilson, sister of Dr. T. J. Wilson, Jr., associate professor of Latin in the university, was found dead in her room this morning.

She was well when she retired. Death must have been caused by heart disease.

At 6:30 o'clock Mr. Llorens, a Cuban student, who rooms in the office building, according to his custom, rapped on her room door to awake her. No response, but her niece, Miss Helen Brown, who was sleeping with her, awoke. She could not awake her and ran upstairs for her grand mother, Mrs. Wilson. She failed to awake her, and called Dr. W. B. McNeider, who said heart disease had probably caused death.

The sad intelligence of the death of Mrs. M. T. Hambrick, mother of our townsman, Mr. W. R. Hambrick, was received here this morning. Mrs. Hambrick was living with her daughter, Mrs. Stanfield at Spring Hope, and had been in feeble health for some weeks. Mr. Hambrick left Tuesday night for her bedside, but the death angel came before he reached there. Mr. Hambrick and family have the heartfelt sympathy of the people here in this sad hour.—Roxboro Courier.
