OVENCOME BY GAS.

Mrs. John Mason Found in Precarious Condition Tuesday Evening.

Mrs. John Mason, wife of the local manager of the Standard Oil company in this city, came near losing her life Tuesday evening in a peculiar manner.

The following interview of Mr. Mason, published in the Daily Sun, of Wednesday, gives a fair account of what was the cause and the result:

"He said that he reached home about 6 o'clock, a little earlier than usual, and found the home looked. There was a gas lamp burning in the sitting room.

"No one answered his ring at the door and he thought Mrs. Mason had probably run out to see some of the neighbors while waiting for him.

He waited and she did not return. Two or three times he looked into the window and not seeing her waited for her return.

"Finally, said Mr. Mason, he made a close inspection and saw her in a chair close by the stove as if asleep.

He tried to awaken her, but she did not answer. He ran up to the house of Mr. W. L. Lougee, on Broadway, and Mr. and Mrs. Lougee came down with him.

They saw Mrs. Mason through the window and he was then decided to break into the home. This was done and her condition was such that a physician was immediately called.

She was unconscious. The gas lamp in the room was burning and this could not have been the cause. The door leading into the dining room was open, thus giving two rooms a ventilation.

It is strange that gas from a stove should have been such as to cause necrosis, especially so with two rooms open, yet it is the only theory that Dr. Albion has of the matter.

The reporter did not talk with Mrs. Mason, but her theory, according to Dr. Albion, is the same as that of her husband that she was sitting by the stove and was overcome by escaping stove gas and was unconscious before she knew what was the matter.

It is estimated that more than 1,500 Durham people visited the new Y. M. C. A. last night, which was the first opening of the building to the general public.

By the hour appointed for the reception of guests committees that had been appointed for the purpose were on hand to show the visitors around the building calling attention to many things that might otherwise be overlooked and to explain anything that visitors might naturally be expected to inquire about.

These committees were distributed about the building in such a manner that visitors were shown through each section of the building by different people, in other words each committee had charge of certain points to show and when this was done the visitor was turned over to another, during which time they were served refreshments, consisting of sandwiches and coffee.

On every hand expressions of pleasant surprise at the arrangement of the building and the interior furnishings.

The Secretary had planned to have another meeting for tonight when organization would be perfected, but on account of the visit of Mr. Claude N. Bennett, who lectures at the Academy of Music, the organization was postponed until Monday, and the promoters are anxious that as many as intend joining will have their application in before that time.

At the organization meeting Monday night officers will be elected and members enrolled.
