Newspaper Laws.
1. A Postmaster is required to give no money to any person who does not answer the law when a subscriber does not take his paper out of the office, and the reasons for it are not being taken, and a notice to do so makes the Postmaster responsible to the public for the payment.

2. Any person who takes a paper from the Post-office, whether directed to his name or another, or whether he has subscribed for it, is responsible for the payment. If any person orders his paper discontinued, he must pay all arrears, or the publisher may continue to send it until payment is made, and collect the whole amount, whether it be taken from the office or not. The publisher is not legal discontinuance until the payment is made.
