The expenditures for the year foot up \$16,433.02. In this amount is included \$4,432.02 for steel and cells of jail. The jail expenses were insolvent fee bills of the year, taken together the exhibit shows that the county affairs have been managed in a very economical manner.

—The Weldon News tells of a madstone in Halifax county. It was taken there fifty years ago by a Mr. Mizell, who lived on the farm of the late Mr. Thomas P. Devereux. The stone is about one and a quarter inches in length and half an inch in diameter. It has three sides, one of which is the color of dark walnut, the other two sides being of a light buff color. One end is smooth, the other rough, as it has been broken. It is porous and weighs sixty-two grains. The stone is a most valuable piece of property, if it is genuine, and there can be no doubt of it. Dr. J. B. Hill, its owner, is willing that it should be thoroughly tested by any one, but is not willing that it should be put into the possession of any other person.
