The board met on the 1st and 2nd, all the members present:

Martin Jones was stricken from the pauper list. William Harris was allowed to go to the poor house, provided he behaved himself. Charlie Morris was continued on the pauper list.

The road running from Social Plain church to Joe Rodger's place in Nash, was made a public road, so as to extend to county. The road from Warrenton, near A. H. Stelling's to Colling Mill, running as the mill path now runs, was made a public road, so as to extend to town. Aaron Ditz was granted license to sell liquor.

Several parties were allowed to list taxes. Nancy Glenn was allowed \$3 as pauper.

No. D. May was allowed a duplicate county order for No. 73, (amt. \$5.40) issued April 6th, the original being lost. The public should be careful in trading for the original order—Editor Times.

The Clerk was ordered to make a statement of expenses of Yan-

cy Glenn, outside pauper, and send to Wake county for payment.

The account of W. J. King, C. S. C., presented at September meeting was recon-

sidered and allowed. The tax books

were delivered to the Sheriff.

The County November term of court

was drawn and ordered recorded.

Some other regular routine work was attended to. In addition to the usual monthly allowance to eligible paupers about \$75 claims to the amount of \$39.14 were allowed and the board adjourned to the next regular meet-

ing.
