> Baron Rosen, Formerly Ambassador to U. S. Present-Two Soldiers Respond to Addresses and Thank Americans


Petrograd, (via London), Nov. 14 .-The American hospital was formally opened today, with enlarged quarters, in the presence of Baron Rosen, jormer Russian ambassador to the United States, and Count Nostriz. City Councilman Sangaill, a patron of the institution, and-George T. Marye, the American ambassador, president of the hospital, delivered addresses. Rus-

sian friends presented the hospital with a portrait of Grand Duke Alexis, the heir apparent. Two soldiers res ponded to the address in English and thanked the Americans for their gift
