### AN ORDINANCE.

An Ordinance Authorizing the Issuance of \$25,000 Bonds of the Town of Louisburg, N. C. for Funding Outstanding Indebtedness.

The Board of Commissioners for the Town of Louisburg do ordain:

Section 1. Negotiable Bonds of the Town of Louisburg shall be issued pursuant to the Municipal Finance Act of 1917 for the purpose of funding the Floating Indebtedness of the said town.

Section 2. The maximum principal amount of the issue of Bonds for funding the Floating Indebtedness of the said Town shall be \$25,000; The maximum rate of interest which said Bonds shall bear shall be six per centum per annum; The maximum period within which said Bonds shall mature shall be twenty-five years.

Section 3. That a tax sufficient to pay the principal and interest of said Bonds shall be annually levied and collected.

Section 4. A statement of the debt of the Town of Louisburg has been filed with the Clerk of said Town pursuant to the Municipal Finance Act of 1917, and is open to public inspection.

Section 5. The average assessed valuation of property subject to taxation by the Town of Louisburg for the three fiscal years in which taxes were last levied, as shown by statement is \$1,363,865.00.

Section 6. The amount of the net debt of the Town of Louisburg, outstanding, authorized or to be authorized, as shown by statement, is \$196,584.05.

Section 7. That this Ordinance shall take effect thirty days after its publication or posting, unless in the meantime a petition for its submission to the voters is filed under said Act, and that in such event it shall take effect when approved by a majority of the voters of the Town of Louisburg.

Section 8. That in fixing the maximum period within which the Bonds hereby authorized shall mature, it has been determined by this Board that the probable period of usefulness of the improvements to the sewer and water supply system, for which these bonds are to be issued, is forty years.

Section 9. That this ordinance be published once a week for four successive weeks in the Franklin Times, a newspaper published and of general circulation in the Town of Louisburg.
