

# State Prisoners Kill Board Reduces Note Steward And Escape w. R. GRIFFIN APPOINTED

Three desperadoes made good heir escape from State's Prison arm near Method Tuesday, leaving whind them the first prison em-

behind them the first prison em-ploye mortally wounded in line of dity here in 20 years. The victim of the desperate bid for freedom by the young white con-victs way 55 H. Brantley camp stew-ard, who was used by the trio as a shield while they forced their way by guards out of the gate. The shooting, described at the prison as "cold-blooded," took place as the trio commandeered a passing car driven by John Monie, Jr., of Raleigh, and the steward grappled with one of the armed convicts. Family Witnesses It In full view of Brantley's wife

In full view of Brantley's wife and 13-year-old daughter, who ran screaming from their home, 100 yards from the camp into the road, one of the convicts fired point-blank at the strugging steward. The bul-let struck him in the head and he died two hours later in a Raleigh hospital.

The prisoners roared down the county road in the direction of Dur-The alarm was broadcast immediately, and a sheriff's posse and a detail of State Highway Patrolmen were rushed to the scene. Last night no reports of the fugitives had been received.

#### **Trusty Describes**

The break started suddenly. It was witnessed throughout by W. T. Alcock, of Pamlico County, a trusty in the prison camp office, who grab-bed a telephone and conveyed a graphic account of the rapid-fire events to Warden H. H. Honeycutt at Central Prison. Alcock said he first saw D. M.

Narron, a foreman, lying uncon-scious on the floor of the building, and the three prisoners marching Brantley out with Prisoner Cook holding Narron's gun in his back. It was developed later that Autrey knocked out Narron with a length of plus of pipe.

The trusty, who said he looked for a gun but was unable to find one, said that the trio marched Brantley across the stockade to the south gate, where they told him to order Guard E. H. Petty to throw

them his gun and open the gate. Guard Petty hesitated. "For God's sake do it or they'll kill us both." Brantley was said to have cried to Petty. The guard complied.
