ELIMINATING PENALTIES AND GIVING DISCOUNT

As Discriminatory Towards Tax Payers Who Have Paid Taxes And In Interest Big Corporations—Receive Delegation of Ladies—Attend to Much Routine The Board of County Commissioners met in regular session Monday with all members present except Beddingfield. After the formalities of opening business was transacted as follows:

A number of ladies and gentlemen from different parts of the County were before the Board in the interest of the Home Demonstration work. A motion prevailed deferring this matter to a meeting of the Board when all members are present.

The report of Jno. Hedgepeth, Superintendent of County Home was received and filed. He reports 17 white and 12 colored inmates. The report of E. C. Perry Superintendent of Public Welfare was received and filed.

A motion prevailed that the matter of the Health Department be deferred until all members of the Board are present. A receipt in full from R. L. Steele and Co., was accepted by the Board.

The bill from the State Hospital at Goldsboro was deferred to the May meeting for investigation by the Auditor.

A motion to pay bill for night letter prevailed. The bill of W. W. Holmes was deferred until May meeting. It was ordered that bills of Incoe, Fleming, Taylor and Franklin Times be paid from revolving fund.

Restrictions Are Promised

The dries, who are much in the minority both in the senate and the house, have the promise of the wets to follow this general bill with a regulatory measure which will provide some restrictions for the sale of beer and the other legalized beverages. Beyond this verbal promise, made in both branches, the dries have nothing but the mercy of their opponents to depend upon.

The Great Dirigible Akron Smashes with 76 on Board, and Smaller Searching Ship Crashes

New York, April 4.—In a blinding electrical storm, the Akron, mightiest dirigible ever to cruise the skies, was plummeted into the turbulent Atlantic today about 20 miles off the New Jersey shore, and by dusk tonight hope had waned for 71 missing members of the crew. Of the 76 men aboard the "mistress of the skies" as she crashed, four were rescued, but one of them died before he was brought ashore.
