

One new point brought to light in the suit is the charge by Senter that Hobgood said, during the hearing, that he acted in anger in citing him for contempt. The charges read, "The defendant made certain findings of fact of which he attempted justify his said unlawful order holding plaintiff in contempt of court, whereupon the defendant admitted in open court that he acted in a fit of anger."

Charging that his "reputation has been-immeasurably damaged," Senter asks prayer for judgment against the defendant in the sum of \$200,000 actual damage and \$50,000.00 exemplary or punitive damages. 
