Radical Extravagance: We took occasion, says the Raleigh Sentinel, several weeks ago, to call attention to the fact that the Legislature had given the various offices of the Executive department unlimited discretion in the expenditure of money...

Radical Extravagance: We have before us the report of the Auditor for the fiscal year, ending September 30th, 1893, and upon a slight glance at the items of the disbursements of the public funds, we find abundant evidence that considerable sums of the people's money have been spent without any direct warrant of law.

Radical Extravagance: We call attention to this matter because there is not one in five thousand of the people of the State who will ever see the details of these expenditures or know for what they were made.

Radical Extravagance: Indeed, on the latter point, the report itself throws no light.

Radical Extravagance: We see, also, that J. W. Hood is allowed \$100 a month, as Agent for the Board of Education, from December, 1892, to August, 1893, except the month of May, when he received \$125. Now, under what law this amount of \$925 is paid out of the public Treasury, we should like to know.

Radical Extravagance: We should also like to know by what law an Agent of the Board of Education, or as the Governor in his message calls him, Assistant Superintendent of Public Education, is appointed and paid, while the Superintendent is allowed a clerk also.

The N. C. Real and Personal Estate Agency Gift Concert.

It is an old saying that "the fools and rascals are not all dead yet," and it has recently received exemplification here in our own State.

Thousands of persons, we venture to make our estimate, bought tickets at the price of \$2 each in the so-called N. C. Real Estate Agency Gift Drawing.

This concert drew had to sell about 100,000 tickets in their lottery, and as their place in August last, seventy-five thousand dollars worth of gifts, including money, houses, farms, pianos, &c., were to be publicly drawn by the ticket holders.

The day at which the first drawing was announced approached, many, yes, many of the unfortunate ticket-holders were already building great castles in the air, when it was announced from the leading press of the concern that not one ticket had been disposed of to warrant the drawing; which, therefore, was far postponed.

This action was manifestly unfair toward every person who had purchased a ticket in good faith, but people silly enough to buy such tickets at all, could easily be imposed on in other matters.

Notwithstanding this postponement, many of the ticket-holders, together with others, were very busy, and in good faith, but people silly enough to buy such tickets at all, could easily be imposed on in other matters.

The time at which the drawing, after the first failure, had been announced finally approached, but the drawing itself did not take place, and thousands of disappointed ticket-holders were again disappointed. Since that time but little has been heard from the concern.

Will not our Raleigh exchange throw some light on the matter? Thousands of disappointed ticket-holders throughout the State are seeking enlightenment.

If the concern started out to be a swindle, and from all present appearance we fear such is the case, the Managers of the concern should be exposed.

But we are the North Carolina Legislature, which incorporated the concern as "the North Carolina Real Estate Agency," equally as much as the Managers. We, for our part, have never indorsed this concern; indeed, we have in one or two instances cautioned the people in this issue to "be ware!"

But to come to the real question of the case. The lots of it (if nothing less it would have been) was an open violation of the laws of our State. Why was it allowed to exist, and with its headquarters at Raleigh, under the very eyes of the Governor, the Legislature, the Supreme and Superior Courts. If a swindle, the concern was a disgraceful and I wess affair, and an insult to every law-abiding person in North Carolina. Let us have light!
