PAYMENT OF STATE BOUNTY DUE DECEASED SOLDIERS.

Ex't. Department, North Carolina, ADJUTANT GENERAL'S OFFICE,

GENERAL ORDERS,) Raleigh, October 17th, 1862. No. 9.

THE FOLLOWING REGULATIONS 'ARE PUBlished for the information of those persons wishing to draw bounty of deceased soldiers in accordance with an ordinance of the Convention ratified the 22d day of February, 1862:

REGULATIONS.

1. The payment of bounty to the representatives of deceased soldiers is based upon the certificate of the Commanding Officer of the company, who will state the time of the enlistment of the soldier, the date of his decease in service, the amount of bounty already paid by the State, and the company and regiment to which he belonged.

2. The claimant will make affidavit before a Magistrate that he or she is the next of kin to the deceased. according to the provisions of the foregoing ordinance of the Convention, and that there is no other person entitled to make claim. The affidavit of the claimant sustained by that of one disinterested witness that the facts stated are correct within his own knowledge, and that he has no interest in the claim. The Magistrate administering the oath will certify to the credibility of the witness, and the Clerk of the County Court will certify, under seal, that he is an authorized and acting Magistrate.
