WEDNESDAY, Feb'y 12, 1873. Senate called to order at 10 o'clock, Lieutenant Governor in the chair. Introduction of Bills. By Mr Flemming, a bill concerning the jurisdiction of Superior Courts.

Mr Ellison offered an amendment 1873 which gives six months to register the hens instead of 60 days as the bill provides. The amendment was adopted. The bill then passed its third reading. On motion of Mr Dudley, the bill to amend chapter 439, laws of 1370 '71, in relation to the fees of Justices of the Peace was taken up and passed its several readings.

On motion of Mr Morrison, the bill exempting persons who have attained the age of 60 years from serving on juries was taken, up, and on motion laid Leave Lilesville ..... on the table.

On motion of Mr Wheeler, the bill defining the powers and duties of County Surveyors was taken up and passed its several readings.

A message was received from the Senate transmitting the report of the Joint Committe to investigate the charges brought against the managers of the Penitentiary, with a proposition to print the same. 


On motion of Mr Morehead, of Guilford, those bills that have passed their third reading were engrossed and sent to the House.


