Winston-Salem, Aug. 13.—The proceedings

in the Senate yesterday were of great public
interest. The president's message was read
and listened to with marked attention by
both sides of the chamber. The speaker
spoke from the floor during the reading
of the message.

The message was referred to the committee
on Finance and its immediate
printing ordered. Mr. Hill (N. Y.) was

the first senator to get in a bill for the re-
peal of the purchasing clause of the Sher-
man Act.

Mr. Stewart of Nevada, fol-
lowed with another bill, and a speech
in which a resolution was offered by Mr. Lodge

(Mass.) directing the committee on Finance
to report a bill for the repeal of the pur-
chasing clause of the Sherman act and pro-
viding for a vote on the passage of such
bill at the end of August. It got no
support.

The resolution was sup-
ported by another offered by Mr. Hale

(Mass.) fixing the hour of meeting of the
Senate and after recess, at 11 a.m.

These rules then precluded discussion

on what should be done.

The debate on the change participated

very evenly without action.

The president's message was awaited by the members of the house with great
anxiety, listened to with intense interest
and afterwards privately discussed from
various standpoints. When the message
was read it was evident the election

from the Fifth district of Michigan was

taken up and after two hours' de-
bate Richardson, the Democrat, was

elected on his prima facie title.
