## Neighboring Rescue Units Called For Assistance In Drowning Incident

rescue units Wednesday morning after an all-day search Tuesday failed in an attempt to locate the bodies of 22 year old Doug Watkins and 14 year old Reba Dupette.

The two young Bryson City residents have been missing since early Monday evening when they, along with four friends, went for a boat ride in the Tuckesegee River.

According to eye-witness reports, these two young people, along with Ann Stanberry, age 24, Peggy Jones, age 23, Shirley Fisher, age 16, and Mike Davis, age 19, left the Tuckesegee Boat Dock around 8 p.m. Monday evening. They used a 12 foot boat belonging to one of the youths father and rented a 4 or 5 hp motor and a lantern attendant, Marshall

### Several Hospitalized As Result Of

A Maryland man was admitted to he Swain County Hospital with undertermined injuries this week as a result of one of five automobile accidents investigated by the State Highway Patrol in Sain County this week.

Officer Z. V. Hawes, assisted by several highway patrol officers, investigated the car-truck accident at the Fontana intersection of US 19 and 28.

Lawrence Allan Morris, age 22, of Maryland was admitted to the Swain County Hospital when the 1964 Ford he was driving was hit on the left side by a tractor and trailer druck driven by O. V. Sawyer, age 40, of Robbinsville. The '64 Ford was estimated to be a total loss.

According to investigating officers, the Morris vehicle was travelling south on N. C. 28 and failed to stop for a stop sign when the tractor and trailer truck, travelling west on US 19, struck the vehicle on he

The accident occurred some 10 miles west of Bryson City at the Fontana intersection of 19 and 28 about 4 p.m. Thursday.
