The John Calvin McNair Lectures at Chapel Hill—How They Were Provided for.

The series of "John Calvin McNair" lectures recently delivered at the University of North Carolina by Dr. Francis H. Smith, retired professor of physics at the University of Virginia, recalls a fact that should be of interest to all Robesonians.

Mr. McNair was a Presbyterian minister who lived near Saint Pauls in this county and died sometime in the year 1857. In his will he devised his lands to the trustees of the University and provided that the lands should be sold and the proceeds invested and the interest used to provide lectures to be made before the student body.

At the time of Mr. McNair's death there was a great deal of discussion owing to the then new scientific ideas that were being spread abroad and there was a great deal of skepticism abroad in the land.

The land became involved in a law suit and nearly fifty years passed before the land was sold and the money placed in the hands of the University trustees, and the lectures recently delivered are the first of the series.
