To be Held in New York City to Illustrate the Dangers of This Dread Disease—Carries the Message That Consumption Can be Cured by Fresh Air, Rest and Wholesome Food. The National Association for the Study and Prevention of Tuberculosis, which is composed of the leading men of the coun- try and is entirely humanitarian and altruistic in its work, is con- ducting an educational campaign against consumption and to this end is sending out press bulletins to disseminate information about this disease. Tuberculosis is the most fatal of all diseases in this State, as elsewhere, and the State Board of Health is co-operating with the National Association in this work, which it is hoped will be the means of saving thousands of lives. The following has been received from the headquarters of the association in New York City: "By November 15th the great- est exhibit on tuberculosis that has ever been gathered will be opened to the public in New York City. The exhibit, which formed part of the recent Inter- national Congress on Tuberculo- sis, will be shown under the au- spices of the Tuberculosis Com- mittee of the Charity Organiza- tion Society, and the Department of Health. "The Exhibition consists of charts. photographs, maps, mod- els, diagrams, and all sorts of paraphernalia that have to do with the prevention, study, or treatment of tuberculosis. Ex- hibits are shown from 15 differ- ent counties, and from 200 asso- ciations and individuals. 
