AN ACT to establish a town at St. Marks, it Florida

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled. That the President of the United S ates be, and he is hereby authorized to cause so much of the publie lands at or near St. Marks, in the Territory of Florida, as he may deem proper, to be laid off into town lots, not to contain more than one quarter of an acre each, and into streets, avenues, and out lots and public agu res for the use of the town, and, whenever the survey of the same shall ted; and the offenders, upon convicbe completed, it shall be the duty of the surveyor for the Territory of Fiorida to cause two plats thereof to be made out, on which the town and out lots shall be respectively designated by progressive numbers ; one of which shall be transmitted, with a copy of the field notes, to the Commissioner of the General Land Office, and the other to the Register of the Indian Agents at Prarie Du Chilan ! office for the proper district. 
