Cotton is now bringing only 10 1/4 cents per pound and there is very little coming in. The farmer is exactly right if he can hold it. The price will surely increase sufficiently to justify him for his trouble.

The Western North Carolina Conference of the Methodist Episcopal Church, South, will meet in this city next week. This is a body of the State's highest citizenship and Salisbury is glad of the opportunity to welcome them, entertain them and enjoy their company while in her midst.

In the loss of the plant and fixtures of the Stanly Enterprise by fire, J. D. Bivins, the proprietor, has our heartfelt sympathy. We have eagerly looked for, read and enjoyed the Enterprise for years and highly appreciate the editor's courageous and sensible way of doing things, and it is our sincere wish that arrangements will be made which will continue the paper's visits to its many friends.

W. T. Thompson, a colored restaurant keeper near the passenger depot, has been bound over to the Superior court for retailing whiskey on Sunday. If Thompson wants to be exempt from such little annoyances he had better get himself straight with the political committee of the whiskey ring. Attention is called to the fact that the blind tiger does not hide himself to the tall timbers because open, "regulated" bars exist in a community.

Mrs. Hall, wife of George Hall, the lonely victim of the court's wrath for the lynching of the Gillespie negroes, August 6th, one year ago, has several petitions in circulation asking the Governor to pardon George. She has quite a number of signers. We do not know George to be the kind of a man to have running at large, but do believe that his punishment in proportion to the amount given his accomplices, nothing, is entirely too severe and unjust.

We have just received the "Biennial Report Superintendent Public Instruction," of North Carolina, by Superintendent J. Y. Joyner. Like the report of the Bureau of Labor and Printing it merely represents a waste of public money. It is well enough to have such statistics gathered and kept in reach of those who may need them, but the publication and distribution of them is where in the waste lies. Such books are seldom given more than a casual glance.

There has been a very decided financial stringency throughout the country, which started in New York. For several weeks a number of banks and trust companies have failed and conditions have not yet, though greatly improved, resumed normal conditions. Quite a number of banks in North Carolina have decided to issue script to be used instead of cash and just why, and where this thing is to stop, is not clear. The action of J. Pierpont Morgan, John D. Rockefeller and the United States Treasury department, who have dumped large quantities of cash on the market at 6 per cent. interest, has done much to restore confidence, and a cargo of gold from England yesterday made things look brighter. Just why the banking institutions in this State should consider it necessary to

withhold cash payments is not generally understood and in some quarters is not approved. The cause of this panicky condition is said to be the result of attacks on incorporated wealth by State governments and the national government. The unfavorable legislation has been aimed at the oppressive and monopolistic tendencies of corporations, trusts and speculators in watered stocks. It is not confined to any one section of the country and has been more detrimental to these interests than others, but, of course, some innocent companies and individuals have been made to suffer. We have no special desire to accuse any one of anything they are not clear of, but, in order to keep history straight on this subject, we call attention to the fact that these things are happening under Mr. Theodore Roosevelt's administration, a republican, and that the occurrence has taken place in the fall of the year 1907. You know politicians make much ado over such matters, hence it may be well to remember some things.

**A Young Man Found Dead.**  
An unknown young white man was found lying at the bottom of a fill between China Grove and Landis Saturday morning by H. H. Troutman. The authorities were notified and an inquest was held by the coroner. His skull was broken and his body bruised and it is thought that he had fallen from a passenger train during the night. \$12 in cash, passes to the Jamestown Exposition made out to D. R. Davis, and a letter addressed to a young woman were found in his pockets, which caused the Coroner's jury to conclude that the remains were those of D. R. Davis, unknown whereabouts. Virginia relatives of Robt. D. Capell, who had been to the exposition, but had not been heard from for several days thought possibly it was he, but after exhuming the remains which had been interred at the county home Sunday, one who knew Capell intimately declared such was not the case. His identity will, therefore probably remain unknown.

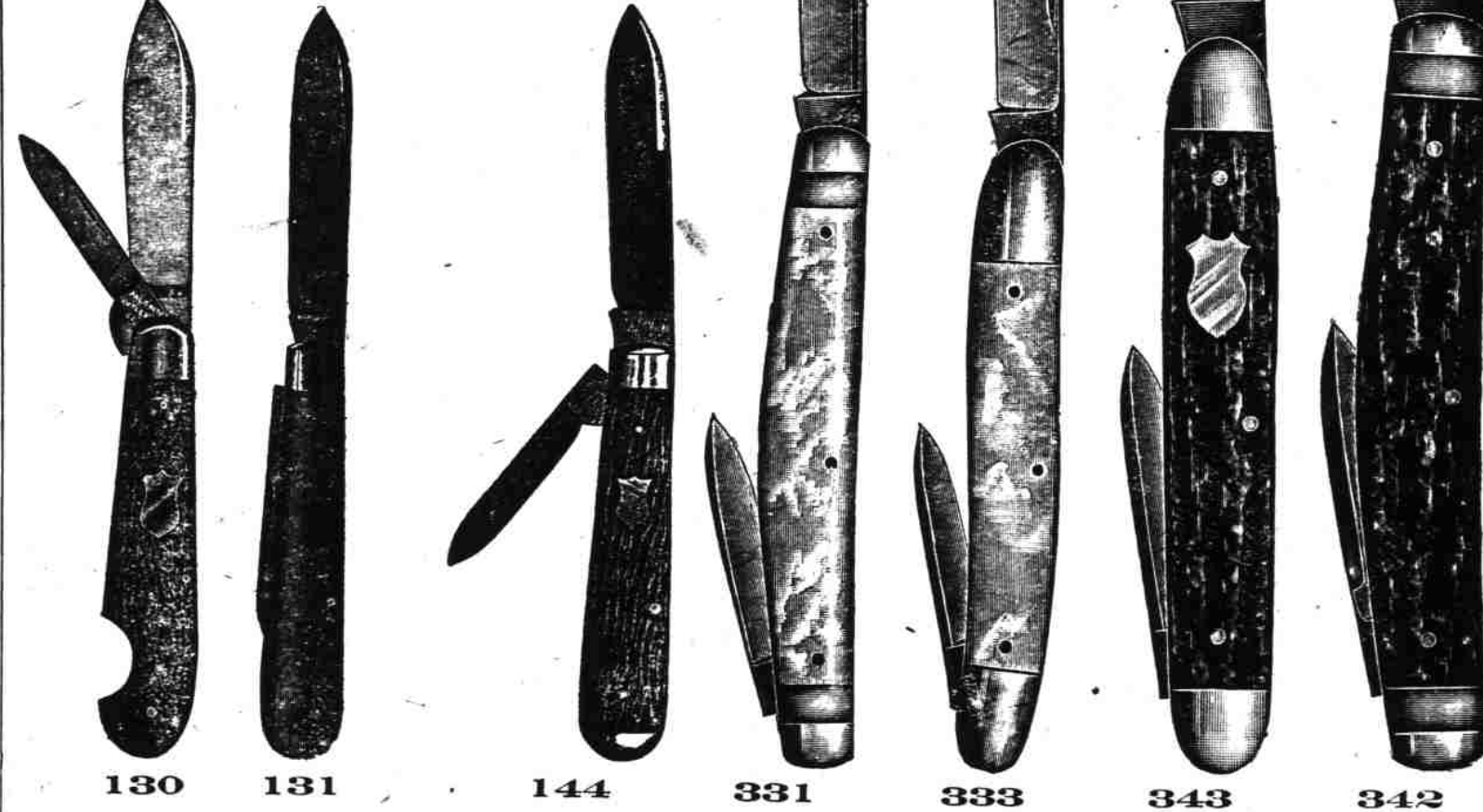
