SHORT LOCAL ITEMS

Stable Lion and J. B. Kerus, tax listers for Salisbury Township, have opened the books in the grand jury room in the court house and request that all who are interested come as early as possible and list their taxes.

The members of the Catholic Church are having excavations made preparatory to the building of a convent school at the corner of Ellis and Council Streets. The school will be managed by the Benedictine sisters.

Milas Meisenheimer, on Thursday, sold eight houses and lots in Salisbury to the Salisbury Realty and Insurance Company. Consideration not stated.

Prof. R. G. Kizer went to Elmwood on Tuesday to select a site for a school house to be built there. The county pays half of the cost for these houses and the school district the balance.

News was received here on Friday of the death of Mrs. D. Carson Lingle, which occurred in Greensboro where she had just been operated on for cancer. Mrs. Lingle had been suffering for some months with the trouble and only submitted to the operation as a last hope. Her remains were brought to Salisbury on Friday night, were taken from here to her home and the funeral was held from Christiana church on Sunday morning in the presence of a large number of friends and relatives. She is survived by a husband, three daughters and two sons. The death of this good lady is rendered all the more sad by the fact that her husband has recently had a relapse of a nervous trouble for which he has been treated at the State Hospital at Morganton. Application has been made for his re-admission to that institution.

John Safritz, a young man of the St. Paul neighborhood, was bitten by a snake while gathering up some leaves at home on Saturday afternoon. The snake bit him on the hand and soon the hand and arm were badly swollen and he was reported to be in a serious condition on Monday. This is only one of several cases of snakes biting people this summer. Owing to the mild winter there seems to be an abundance of snakes this season, they do not care anything about the prohibition law.

Little Johnnie, the nine-year-old son of Mrs. Jennie Shuman, of Black Mountain, who is visiting friends in the City, was painfully hurt on Friday morning by falling or jumping off a street car on South Main Street. The boy and his mother were on their way to the home of Mrs. R. V. Lamir for dinner, and after the accident he was taken there and given medical attention.

C. A. Brown has been elected president of the Cleveland Oil and Fertilizer Company to fill the vacancy caused by the death of J. M. Harrison. The capital stock of this company is \$20,000 and it has just declared a dividend of seven per cent, besides adding a neat sum to its surplus fund.

The series of meetings which Evangelist Will Uphaw, of Georgia, has been conducting at the First Baptist church for the past two weeks, closed on Sunday night. During this meeting a number of people were converted and added to the membership of the church.

All of Salisbury is gratified to know that Rev. Byron Clark, pastor of the First Presbyterian church, is to remain with us indefinitely. He has just declined a call extended to him by one of the leading Presbyterian churches of Nashville, Tenn. Dr. Clark has been attending the meetings of the Presbyterian General Assembly, at Lewisburg, W. Va., and went from there to Nashville, where he filled the pulpit of the church to which he had been called on May 28th. It was an inviting field with an increase of salary, but after carefully considering the matter Dr. Clark decided to remain with the Salisbury church. The church to which he was called is the same one which was lately served by Rev. G. H. Cornelison, former pastor of the First Presbyterian church of Concord.

A man who gave his name as B. S. Pearce, who claimed to be covering the national highway from Atlanta to New York in the interest of the Atlanta Journal, came to see us on Saturday morning. He had a newsboy's sack, an umbrella with "Atlanta Journal" printed on them and wears a suit of overalls. He stated that he is looking after the signs along the road, seeing that they are all in place and reporting those which are down. He says that he walked from New York to Atlanta in seven weeks and thinks he can make the return trip in five weeks.

Our Editor left at 8 p. m., on Tuesday for Wilmington to attend the Press convention, which meets at Wrightsville to-day, and get his first glimpse of the sea. It is not after that he tears himself away from his work, and we wish him a jolly time.

Meeting of City Aldermen.

The city aldermen met on Thursday night and much business of importance to the city was transacted, among which was the adoption of the all night lighting system. The moonlight schedule has been tried for the past month and has proved unsatisfactory. Many complaints have been made, and, while the city fathers wish to run the affairs of the city as economically as is possible they felt that it was their duty to comply with the demands of the people to restore the all night system of lighting.

Alderman F. M. Thompson carried a very important point relative to unclaimed articles and property taken from prisoners by the policemen. The law in regard to this shall be enforced. The chief of police shall keep a record of all valuables of whatever character taken from prisoners, they shall be turned over to him by the officer making the arrest and shall be returned to the owner. All unclaimed articles shall be advertised and sold.

The bond of chief of police and city tax collector, Jerry M. Brown, which is \$10,000, was presented and accepted.

The bond of city clerk Stable Lion was fixed at \$1,000. The bond of city treasurer R. W. Price at \$20,000. These bonds will be given at the next regular meeting of the board.

Alderman Thompson formerly tendered to the Board the resignation of A. H. Boyden as a member of the city school board. The resignation was accepted with regret and expressions of appreciation for services rendered. Alderman J. Samuel McCubbin stated that Mr. Boyden desired Frank R. Brown to be his successor, and he moved Mr. Brown's election. Carried.

The ordinance relative to muzzling dogs did not pass.

The revenue act, which included a special ordinance on near-beer, was put on its second and final reading. After discussion the act was passed and becomes a law.

The special ordinance on near-beer follows:

Be it ordained by the Board of Aldermen of the city of Salisbury:

1. That every dealer in beer, malt or drinks under any name or description whatsoever, containing as much as one half of one per cent alcohol, shall pay an annual license tax of \$50, and no license shall be issued for a less period than six months and the ordinance shall be subject to the Board of Aldermen and upon their approval of the same by proper orders.

2. That all licenses granted by the city of Salisbury to sell drinks or beverages under any name or description whatsoever, containing as much as one half of one per cent alcohol including all license heretofore granted and under which present dealers are now conducting their business shall hereafter entitle the holder of such license to sell such beverages only in the following manner and subject to the following terms and conditions:

3. It shall be unlawful for any such dealer to conduct such place of business elsewhere than in a room, the interior of which is in full view from public street.

4. It shall be unlawful for any such dealer to keep his place of business open or to sell, or offer to give away or furnish such beverage except between the hours of 6 a. m. to 11 p. m. Said place of business shall be closed and kept closed on Sunday.

5. It shall be unlawful for the view from the street of the interior of the place of business of such dealer to be in any manner obstructed, whether by screens, curtains, partitions, stained glass or otherwise; and during the closing hours aforesaid there shall be kept and maintained in the room in which such business is being conducted sufficient light or lights to enable the entire interior thereof to be plainly seen from the street.

6. It shall be the duty of the captain of police or some one acting under his direction to visit such places of business as often as may be necessary for the purpose of inspecting the stock of such dealer and doing all other things necessary to ascertain if any of the provisions of this ordinance is being violated.

7. It shall be unlawful for any such dealer to keep, to have on hand, permit or allow in such place of business any intoxicating beverage or any kind or description whatsoever.

8. Any person violating any of the provisions of this ordinance shall be guilty of misdemeanor and shall be fined fifty dollars and in addition shall forfeit his license, and whenever a forfeiture of license is declared, no part of the tax paid for same shall be refunded.

9. That all ordinances and parts of ordinances in conflict with this ordinance be and the same are hereby repealed.

10. This ordinance shall be in full force and effect from and after the date of its adoption.

Proceedings of the County Court.

Judge Miller had, only two cases to dispose of in the County Court on Monday. They were cases that should have been handled last week. John Lindsay, a Charlotte Negro who has been held since last Monday charged with cutting his wife's hair, was found guilty and was fined \$10 and the cost. There had been a fine of \$5 and the cost assessed against him last week for being drunk, but he was told by the Court that if he paid to the \$10 fine and cost in both cases he would be allowed to go, otherwise it was 90 days on the roads.

Lindsay's wife had gone back to Charlotte on the day she was cut and it was thought that she would not return to appear against him, but she did. She showed such venom and spite on the stand that many believed that she provoked John to cut her and deserved all she got.

The other case was against Lou Hill for raising a disturbance on the 30th in which her brother Lorenzo Hill cut Jim Walker in the back. Lorenzo was convicted last week and sent to the roads, but Lou could not be found at that time. She was found guilty and judgment was suspended upon payment of the cost and some back cost which she owed the court.

This finished the docket. That not a single case appeared from Saturday morning until Monday is a remarkable showing for a city of this size and reputation of Salisbury and speaks well for her.
