EDITORIAL CORRESPONDENCE.

General Amnesty—Railroad Schemes before the Legislature—Work Houses—Election of Councilors of State, &c.

Dear Journal—Many subjects of important legislation have been introduced during the past week, but none have been finally acted upon.

The subject of railroads is the great question of public interest. Finance and taxation are quiet as yet, waiting the publication of the Revenue bill and report of the Public Treasurer, which will not be laid on the desks of members until to-morrow.

The Western North Carolina Railroad, in a bill introduced by Mr. Avery, the attentive and intelligent Senator from Burke, asks that the Public Treasurer be authorized, whenever it becomes his duty, under the acts of previous General Assemblies, to issue to this corporation bonds to the amount of fifty thousand dollars or more.

Mr. McKay, one of the Commoners from the county of Cumberland, has introduced a bill in the House to enable the Western Railroad to complete its road from the Coalfields to some point on the North Carolina Railroad.

Mr. Jones, the Senator from Wake, has introduced a bill to grant the aid of the State to the Cheraw and Coalfields Railroad, authorizing the Treasurer, that whenever five hundred thousand dollars are subscribed by other States, counties, responsible persons or corporate bodies, to subscribe a similar amount, to be paid in the stock held by the State in the North Carolina Railroad at the par value thereof.

Mr. Whitfield, one of the members from Cleveland, has introduced a bill to enable the Wilmington, Charlotte and Rutherford Railroad to complete its road, pay its debts to the State, and extend its road to the Tennessee line.

Mr. Love, the Senator from the extreme Western District, has introduced a bill to consolidate all the roads, finished and unfinished, from Beaufort Harbor to Duck Town and Paint Rock to be called the North Carolina Central Railroad Company.

All of these roads are before the committee of Internal Improvements of the respective Houses, and as yet none of them have been reported upon.

important and judicious amendment to the act of the last Legislature establishing Work Houses, enabling two or more counties to unite and build a House of Correction, with all the rights and privileges granted under the original act.

The election held on Saturday for seven Councilors of State resulted in the election only of Mr. Wm. A. Wright, of Wilmington, and Wm. Eaton, Jr., of Warrenton.

The election of Judge Manly to the United States Senate does credit to the General Assembly. The outrage perpetrated upon this eminent jurist by the last Legislature, has been properly repudiated, and whether Judge Manly ever takes his seat or not, the representatives of the people have reflected their wishes in this manifesting their confidence in the abilities and wisdom of this gentleman.

It is rumored here that Hons. John Pool and G. W. Logan have gone on to Washington City, to prevail upon Congress to carry out the views of the "Union" men of this Legislature, in regard to reducing us to a Provisional Government.

We are now brought to consider another subject relating to the negro's condition; and one upon which his usefulness in the broad field of Southern industry will very greatly depend.

Under our former system, when every necessary want of the slave was provided for without his exercising any forethought, no mental development was required, beyond what was acquired in the every day practice of that industry which was exacted and enforced by the master.

As a suitable channel through which the benefactions of our Church to the Freedmen's Aid Society of the Methodist Episcopal Church have been at our disposal, we are designed to co-operate with our missionary work in the South, and in fact to supplement that work.

"We also recommend that the Churches in the East contribute with special reference to the establishment of schools in the Southern States bordering upon the Atlantic, and that the Churches in the West direct their efforts especially to the States lying South of them in the great Mississippi Valley.
