STATE OF NORTH CAROLINA,) TREASURY DEPARTMENT, Raleigh, April 24, 1867.

To List Takers and other Revenue Officers :

Various questions as to the construction of the Revenue law have been addressed to this Depart-ment. I give below, in substance, my answers, in the hope that they may be of service to officers administering the law. The following extract from a late order of Maj. Gen. Sickles, will show that the collection of the State taxes must be made, notwithstanding the recent Act of Congress placing the State under military rule :
