Mr. Morehead, from the Committee on Constitutional Reform, reported a bill providing for the call of a Convention to meet in Raleigh on the 6th of September, 1875, for the purpose of considering and adopting such amendments to the Constitution as they may deem necessary and expedient, subject only to the restrictions hereinafter provided. The bill provides that the election for delegates to said Convention shall be held on the first Thursday in August, 1875, and that it shail consist of one hundred and twenty delegates. The Convention shall have no rower to consider, debat-, adopt or propose any amendment to the existing constitution or ordinance upon the following subjects : Homestead and personal property exemptions, mechanio's and laborer's lien and rights of married women as now secured by law, nor to alter or amend section 3 or 5 of article 5 of said Constitution, nor change the ratio between poll and property tax as therein established. Both parties claim the majority of the senatorial districts. The Democrats claim the House by 15 to 20, while the Republicans also claim 13 majority in the same body. In the first Congressional District the election of Jones, Democrat, is conceded by both parties .-Blair is elected over Kent, Democrat, in the Third District, while the Second is still in doubt-confidently claimed by both parties. The Monitor, Republican newspaper, claims that Pike and Biair, both Republicans, are elected to Congress; that the Republicans have a good working majority in the House of Representatives, and that the Republicans have elected 6 of 12 Senators, with several districts in d ubt. The Patriot, Democrat, says that there is no election of Governor by the people; that the Republicans have five Senstors and the Democrate five, with two districts in doubt, and that the Democrats have a majority in the House of Representatives. The Patriot also claims the election of Jones the Third District in doubt. The Paople (Democrat) also claims a substan tial victory for its par'y, with the ex-ception of the Taird District, which it considers doubtful. HEADQUARTERS.
