NORTH CAROLINA.

BAUFORT, N. C. via MOREHEAD CITY, Dec. 1.—The largest fire that ever occurred here took place about 2 A. M., and was evidently the work of an incendiary. The loss was very heavy and the insurance comparatively light. About twenty-five stores were burned, comprising all that portion of Front street, between Turner and Orange, with the exception of two private dwellings. Many of our citizens lost everything, and much distress will result therefrom.

OHIO.

CINCINNATI, Dec. 1.—A freight train on the Kentucky Central jumped the track and ran down an embankment. The engineer, Wm. Thomas, was killed. The engine and ten cars were wrecked.

NEW YORK.

New York, Dec. 1.—The steamer *Savoyard* was sunk to-day by the ice. The crew here thinks that four or five lives were lost.

At a late hour last night O'Connor's physicians held out hopes of his recovery, providing he suffers from no relapse.

The police prevented a public drawing of the lottery for the erection of a home for the homeless children. The drawing was conducted privately.

MARYLAND.

BALTIMORE, Dec. 1.—A special meeting of the stockholders of the Baltimore & Southern Steam Transportation Company is being held here to-day, to take into consideration the best means of closing the business of the Company. A resolution was adopted turning over the property to the Directors to be used for the benefit of creditors. The total indebtedness is \$20,000. Mr. D. J. Foley, President of the Company, stated that steamers would be run as usual. The steamer of the Company lay between this city, Charleston and Wilmington, N. C.
