 The Board of Justices for Columbus County convened at Whiteville on yesterday and elected the five following named gentlemen to serve as County Commissioners for the ensuing two years, viz: Melton Campbell, G. W. Elkins, Jonathan Gore, J. J. Long and D. S. Cowan.

Revenue Cutter and Officers.

From Captain E. H. Craumer, pilot of the Revenue Cutter *Colfax*, who arrived in this city yesterday, we learn that the work of improving the *Colfax* was begun about two weeks ago, at Wilmington, Del., and that the cutter is expected to be ready for duty about the 1st of October. We regret to learn that most of her officers have been ordered to different stations and the hope of their returning among us has vanished. Lieut. F. Munger is awaiting orders. Lieut. Jno. U. Rhodes is on a leave of absence, which will expire in a few days and it is not known where he will be sent. Lieut. F. J. Simmons is ordered to the cutter *Crawford*, at Key West. First Assistant Engineer C. F. Coffin is ordered to the cutter *Dix*, at New Orleans. Second Assistant Engineer D. M. C. French, to Rev. cutter *Seward*, at Pensacola. Capt. Barr and Chief Engineer Chevers are with the *Colfax*, at Wilmington, Del. We trust the gentlemen will find it convenient to stop here for a few days on their way to their new posts of duty. We but speak the sentiment of all who know them, when we say a clever set of gentlemen were never stationed at this port.

Enforcing the Quarantine.

In view of the fact of the prevalence of that dreaded disease, yellow fever, in various points to the South of us, Mayor Fishplate has determined to enforce a strict quarantine by land as well as that now in force by sea. He gives notice that a policeman will be stationed at the depot on the arrival of each train and that no person from infected ports will be allowed to stop here. This quarantine is to be kept in force until November 1st.

Robeson County.

We have been shown a letter from a prominent gentleman in Robeson county, relative to the recent reelection. It would seem by it that our friends up there were caught napping this time. The vote in the county was about 600 less than it was two years ago, and that is just where the trouble came in. The greater part of this loss in votes was in Democrats who could not be aroused and made to register and vote while the Radicals polled very nearly their full strength. The writer says he is not sure but the election will yet be contested, notwithstanding the declaration of the Board of Canvassers. The returns from Smith's township came near being thrown out by the Board as the registration was not revised as the law requires. The polls were not opened until 8 o'clock and the voting was done from the old registration books of two years ago.

Criminal Court.

The following cases were brought up for trial this morning:
 State vs Charles H. Grant, special policeman, for assault and battery. Jury still out. (The prosecutor in this case is one George Saunders, colored, who was arrested by Grant for disorderly conduct in the First Ward on the day after the election, and brought before the Mayor's Court. The Mayor discharged the case, and Saunders swore out a warrant against Grant before J. G. Hill, a colored Justice for assault and battery. Grant was fined \$25 and costs, from which an appeal was taken to the Criminal Court.)
 State vs Alexander Stewart, for larceny. Now on trial.

Large Foreign Mail.

Postmaster Brink informs us that there were two hundred and thirty-eight foreign letters in the mail which was distributed at the Post Office in this city last night. This is considered a very large foreign mail, but it only goes to show that the trade of Wilmington with foreign markets is rapidly increasing.

We understand that Mr. Louis J. Otterburg, formerly of Fayetteville, has leased the commodious store No. 27 Market street and will open a merchant tailoring and clothing establishment there about the first of September, with a new and handsome stock of goods.

The Board of County Commissioners met yesterday afternoon in regular session, present Mr. Wagner, the Chairman, and Commissioners Worth, Atkinson, Sanders and Holme.

It was ordered that Dr. M. Holden be allowed to list his taxes in Masonboro Township.
 Ordered that Ed. A. Alderman is hereby appointed a student at the University of North Carolina, under the provisions of section 3 of the Act of Assembly of February 11, 1867, and that the Clerk of the Board correspond with the President of the University and inform him of this appointment, and also furnish said Ed. A. Alderman with a certificate of his appointment under the provisions of said act.

Ordered that the Clerk of the Board be instructed, to notify the agent of the steamer *Passport* that the Board requests him to produce evidence that said steamer is listed (for taxes) in New York.

Ordered that Rev. J. F. Hill be granted permission to erect a small house of worship on the Poor House grounds, the spot to be selected under the supervision of the Chairman of the Board, said house to be open to all religious denominations.
 David Lock, of Cape Fear Township, was exempted from road duty on account of physical disabilities, on a physician's certificate and recommendation.

The Board then took a recess until this evening, at 5 o'clock.

Board of Aldermen.

The regular monthly meeting of the Board of Aldermen was held yesterday afternoon, present, the Mayor and Aldermen Bowden, VonGlahn, Vollers, Foster, King and Hill.

The Finance Committee reported on the application of Mrs. Robt. Strange, recommending that it be indefinitely postponed. Carried.

The petition of John J. Rhodes, asking for appointment as a city detective, was referred to the Committee on Police.

A petition from sundry retail dealers in reference to hucksters, was referred to the Committee on Market and Fees.

A petition from sundry citizens, in reference to goats running at large, was referred to the Sanitary Committee.

A petition from C. Stemmermann, asking permission to extend his stable adjoining Lippitt's row, on Front, between Dock and Orange streets, was referred to the Committee on Fire Department.

A petition from Mott & Campen, asking permission "to move a shop on Market street, to a vacant lot on Front street and J. E. Lippitt's alley," was referred to the Committee on Fire Department.

A petition from W. B. McKay, asking permission to extend a wooden store, on Market street, between Second and Third streets, 20 or 30 feet back, was referred to the Committee on Fire Department.

A petition from L. Chapman, weigher of beef cattle, in reference to a reduction of the amount charged him by the city for the next year, was referred to Committee on Market and Fees.

The Mayor was instructed to have the ordinance in reference to chicken coops and other obstructions on the sidewalk enforced, especially on Water street, it being a narrow street.

An application for a 400 barrel cistern be built on the corner of Seventh and Wooster streets, was referred to the Committee on Fire Department.

Report of Superintendent of Health for the month of July was read and ordered on file.

The Board then adjourned.
