Price, \$2 a year. Magistrate's Court. In Justice H. E. Scott's court this morning, Lewis L. Smith, colored, of Fayetteville, charged Moses Hawkins, colored, of this city, with the larceny of the goods and chattels of the said Smith, the same being in money to the amount of four dollars and fifty cents, which was committed on Saturday night last. The testimony against Hawkins was conclusive, and he was held in the sum of \$200 for his appearance at the next term of the Criminal Court, but in default of adequate sureties to his bond, he may, for the present, be found on Princess, between Third and Fourth streets, to which place all communications may be addressed. C.: SIR: The heartrending cries of destitution and suffering coming from the dens of pain and affliction in the districts where the terrible scourge has established its habitation, prompt the undersigned to bespeak your interest in behalf of the following proposition: The undersigned is willing to deliver a lecture on some secular theme, the proceeds of which to be devoted to the partial relief of the sick and impoverished victims, and respectfully suggest that your Honor appoint an influential committee to make all the necessary arrangements, determine on the day and hour, obtain a hall, issue tickets, &c., and notify him of the result of their deliberations and labors, when he will gladly obey their call. The Cause of the Excitement. Everybody wanted to know what the excitement was on Market street this forenoon and on enquiry we ascertained that Mr. A. Shirier, who has just returned from the Northern markets, was opening a big installment of his Fall and Winter stock of clothing, furnishing goods, hats, &c. We took a privileged peep at what was going on inside and saw the counters and shelves piled high with the elegant stock now being opened there. Poor and Sick. A poor white man, whose name we did not ascertain, was taken sick and dropped on the grass this afternoon on Third street, near Chestnut. His wife and child were with him. The poor fellow lives somewhere near the Poor House, and had been here to look for work and was on his way home when taken. Information was lodged at the City Hall, and Captain Cowan sent for Dr. Lane, who gave him some medicine. The family were then placed in one of the "city carts and sent home. Sudden Illness of Dr. Wright. We deeply regret to learn of the sudden and severe illness of Dr. A. E. Wright. He was sitting at his desk today about 12 o'clock, writing and conversing with a friend, when he suddenly fell back, stricken with paralysis. Dr. J. C. Walker was fortunately near at hand and was called in to his assistance and Dr. W. W. Lane soon after arrived. It was ascertained that his entire right side was affected and the stroke, we regret to learn, is considered a severe one. He is almost speechless, unable to articulate distinctly, and unable to move either of his right limbs. How far the paralysis extends in the direction of the vital organs has not yet been ascertained with certainty. He is now at his room over Burbank's drug store, corner of Front and Princess, where he is receiving every attention that the devotion of his friends can suggest. We can only trust that we will be able to report his condition to-morrow as improved. Saturday Night.
