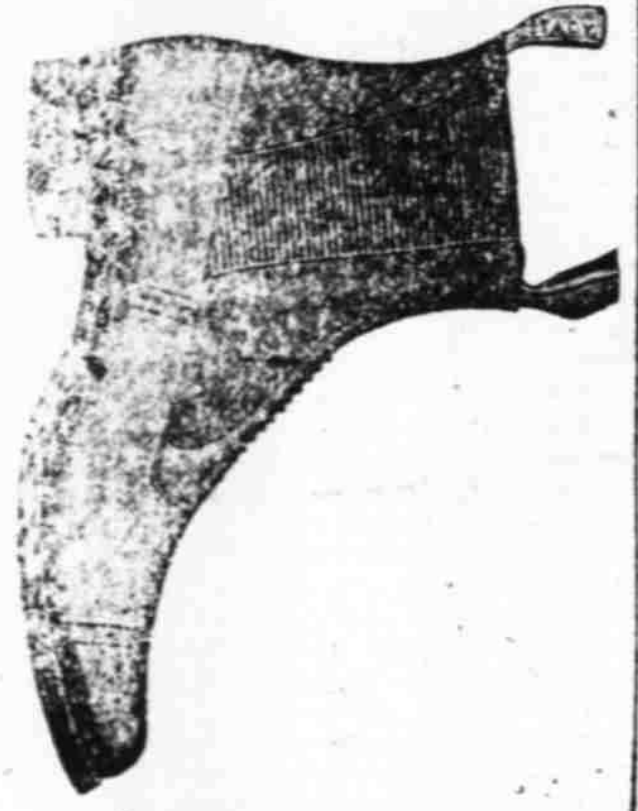

Third Class Mail Matter.

The recent opinion of the Assistant Attorney-General for the Post-office Department, by which invoices, bills of lading, circulars and the like are stricken from the list of third class mail matter, is a decision of serious concern for the business community. Why not make *everything* third class matter that the sender is willing to send unsealed?

Over Three Months Out.

We learn through the Signal Office in this city that a schooner, name not reported, but said to have sailed from some port in New Hampshire, bound for this port, about two months ago, put in at Lookout this morning and sailed again soon after. She is not reported as being in distress and this is all that can be ascertained regarding her. It is thought here, however, that the schooner is the *Clara G. Loud*, Capt. OPERA HOUSE.

Lucretia Borgia.

Miss Ada Gray and supporting company were greeted by a very flattering audience on their first appearance here last night, for the really inclement weather did not deter a very large representation of both fashion and intelligence from being present.

Of the fearful tragedy presented, there can be but one opinion—that it is the most horrible, in plot and incident, in the whole range of dramatic literature, the imagination of the author even outstripping historical facts, as terrible as they are in connection with the dreaded Borgias. But it has been a favorite with a class of the heavy tragedy school and requires an actress of great physical powers to attempt its portrayal. These Miss Ada Gray, who assumed the title role, certainly possesses in striking development; yet, while she exhibited evidence of fine dramatic taste, and gave us some very excellent acting, still she cannot be ranked as an actress of the highest order of merit. We consider her "Lucretia Borgia," however, a fair success, and believe her capable of greater things.

The support was only about the average. The costumes were very creditable, but there was nothing remarkable in the acting of any of the supporting gentlemen. Mr. Murphy, we believe, had a good conception of "Genaro," but did not verify the promise in the practical personation.

We look with interest to the play to-night, which we trust will afford a pleasanter variety than the tragedy first given. To-night is positively the last performance here.

The Suit Against the Wilmington Market Company.

The suit of Mr. J. K. Vaughn against the Wilmington Market Company, before a Justice of the Peace, to enforce a builder's lien, which was continued until the 14th of January on account of absence of witnesses came up for trial yesterday morning. It will be remembered in our previous reference to this case we stated that a jury had been demanded by the plaintiff and that the jury had been duly impanelled. The jury were on hand ready to sit upon the case but the matter was decided by the court upon a question of law and the case did not reach the jury. The question submitted by Major Devane, counsel for the defense, was that the lien was illegal, and not according to the requirements of the statute made and provided in such cases. The court decided the point well taken and counsel for plaintiff, F. H. Darby, Esq., entered non suit for his client, the case being dismissed at the plaintiff's cost.

The New Red Book.

We have received a handsomely bound copy of the new B. & O. Red Book. It is issued by the Baltimore and Ohio Railroad Company, and while it is in one sense an advertisement of that road its chief aim has been to present the returns of the late election in such form as will most clearly show its results, and to this end the returns of previous elections are shown, and from them the gains and losses compiled. A second edition will be issued within a few weeks giving the Presidential returns by counties in each State, and showing comparisons with the vote of 1876 with majorities, gains and losses.
