against the defendant. This being the
only business on docket the Court then
adjourned.

ed considerable amusement as well as

on Front street. He made it a point to
address every one to whom he spoke
with a title. To one he would prefix the
dignified title of "Judge" as he called it

the way he gave the no less respectable
title of Doctor. The spirits country had
swallowed were effervescing to a lively
degree, when, unfortunately for himself,
he invaded the private premises of a resi-
dence on Front street and frightened
the inmates, which caused country's ar-
rest by a policeman. This caused our
rural neighbor to become quite indignant,
when the services of a second policeman
were required, and under escort of the
two, country was taken to the public
lodging house in the basement of the
City Hall where he will repose until his
exuberant spirits are cooled by slumber
and reflection.

Dedication of a New Catholic Church at Laurinburg—A Large Crowd in Attendance.

Yesterday morning an excursion train
left the Carolina Central depot at 6:15,
carrying a large number of persons to
witness the dedication of the new Catho-
lic church at Laurinburg. Aboard the
train was the celebrant, Rev. Father
Gross, of St. Thomas' Church, Masters
A. Childs, W. Flanagan, John Donlan,
Pat Dowling, Hugh Gallagher, Walter
Bailey and John Barry, acolytes of St.
Thomas' Church, and the choir of the
church, Mrs. John G. Bauman, Miss Sue
Reilly, Mrs. D. O'Connor, Miss Matilda
Bauman and Mr. John W. Reilly and
many of the most prominent and worthy
members of the church.

A Review reporter accompanied the
excursionists and we are enabled to-day
to give the following particulars of the
trip and dedication:
The train stopped at all stations on
the road and the number of the excu-
sionists when the train arrived at Laur-
inburg amounted to about three hundred
souls.

St. AUGUSTINE'S CHURCH
is situated on a beautiful little knoll on
a main street about two squares from the
depot and is surrounded by neat new
frame dwellings which are fast approach-
ing completion. The edifice is a neat,
high-pitched, well-ventilated frame struc-
ture, nicely painted and is appropriately
finished with a neat cupola or small bel-
fry over the entrance to the sacred build-
ing.

The interior of the church is finished
with hard pressed walls and enameled
paint and the entire building is con-
structed of the best selected heart lumber.
The church is built very much after the
plan of the main floor of St. Thomas'
church of this city. In the choir, over
the front entrance, is a fine organ, which
was a donation from St. Thomas' Church
as were also the altar and altar vest-
ments. The interior of the building is
finished with a clear pitch of 24
feet, and has an easy seating capacity for
150 persons. The altar is in imitation
marble and is an exact counterpart
of the marble altar of St. Thomas'
Church. It was made in this city and is
as fine a piece of workmanship as we have
ever seen. It was appropriately dressed
with floral offerings, candles and crosses;
and above it was suspended a handsome
oil painting, "The Crucifixion," which
was executed by Sister Mary Charles of
the Academy of the Incarnation, of this
city. It is 8x4 1/2 feet and is an exact
copy of a very old and renowned paint-
ing which was executed in Rome during
the early days and which has been hand-
ed down from generation to genera-
tion and is now looked upon as
one of the greatest master pieces of this
art. Half an hour after the arrival of
the train in Laurinburg, Father Henry,
of this city, who was Master of Ceremo-
nies, announced the readiness of the Cele-
brant to

DEDICATE THE CHURCH.
A short prayer was said by the cele-
brant and Father Henry. The choir
then sang a beautiful dedicatory psalm.
During the singing the Cross bearers and
two acolytes preceded the reverend
priest in their march around the church
edifice, while the celebrant blessed the
exterior walls and sprinkled them with
hallowed water; a short prayer was re-
cited at the door of the church and the
congregation entered, following the Cele-
brant, Father Henry, the Cross bearers
and acolytes repeating the Litany as
they approached the altar. A tour was
made around the interior of the church,
the Celebrant blessing the walls and
sprinkling them with holy water.
The dedicatory services being finished

HIGH MASS
was sung by Father Henry. Father
Gross preached a very interesting sermon
and was attentively listened to. His sub-
ject was, "This is the House of God, the
gate to Heaven."

During the High Mass the following
celebrated masses were sung: *Kyrie* and
Gloria in Excelsis from Concone's Mass;
Credo and *Santus* and *Benedictus*
from Peters' Mass; *Agnus Dei*, from De
Montes' Mass, the offertory hymn
Benedicite, by Bains, and after the mass
the beautiful hymn "Strike the Harp,"
by Peters.

BEFORE VESPERS
The sacred rite of baptism was adminis-
tered by Father Gross to two children.
At Vespers the Celebrant preached a
sermon on "The Presence of Christ in

the Blessed Sacrament," and after the
sermon, which was pronounced a very
fine one, he gave the Benediction and
administered the sacrament to quite a
number of communicants. At Vespers
was sung *Veni Creator*, by H. Dielman,
O! Salutaris, by Lambillette and
Tantum Ergo, by the same composer.
At the conclusion of the services Peters'
beautiful hymn, "Strike the Harp," was
again sung and the congregation dis-
persed, and wended their way to the
train. Father Gross remained in Laur-
inburg last night and was to leave to-day
for Charlotte or the Convent at Hickory.
The little band of working residents of
Laurinburg deserve much credit in the
erection of the pretty little church,
which stands to-day as a monument to
their zeal in the faith of which they are
firm believers. To the energy of Capl'
Maglenn, possibly more credit
should be given than to others, but they
contributed their mites with an open
heart and hearty Amen. The excursion
train left Laurinburg at 5 o'clock and
arrived in this city at 9:15. Every one
was well pleased with the trip and all were
agreeably surprised at the beauty of the
handsome little church, the dedication of
which called them from their homes.

The government steamer *Atlantis*,
Captain Brown, employed as a buoy ten-
der on the coast between this point and
Charleston, put in at this port this after-
noon and tied up at the government
wharf in the lower part of this city.

Murder at Whitaker's.
A correspondent at Whitaker's in-
forms us of a murder which occurred near
that place last Saturday morning. Geo.
Griffin and Blake Ricks, both colored
laborers, were employed on the farm of
Mr. J. M. Mayo. While getting their teams
ready for the day's work on Saturday,
they quarreled and Ricks struck Griffin
with a heavy club on the temple, felling
him, and then struck him again on the
back when down. Ricks fled and Griffin
managed to scramble up and with some
difficulty he was conveyed to a hospital
and died within about one hour after being
struck. The murderer has not yet been
captured.
