





The Utes have been unfairly, even brutally, treated in the past, and it is not difficult to suppose that their teeling was the reverse of amiable, but in the lights now before us we fail to see that they have been the aggressors. The whole episode suggests the idea of an organized effort to embroil them by goading them thto violence.

We are glad to observe a disposition on the part of the government to do these heipless creatures justice. Mr. Muldrow, Acting Secretary of the Interior, has just sent to the Governor of Colorado an order that will receive the approbation of the whole country, and that ought to put an end to the troubles. 


