California politicians just arrived in Washington say the recent canvass in that State was not decided on any national political issues. It was on purely local issues and the most abundant use of money. Senator Stanford desired a re-election to the Senate and opened his money bags. According to some of the Californians he spent at least a million dollars, but this is probably exaggerated.

President Harrison's message has been read and digested and opinions upon it are now in order. Viewed in the light of facts—and well known facts at that—it seems to us trifling with the truth. In some things it is an insult to the intelligence of the people. It describes a state of affairs which do not actually exist, which is notably apparent in the petty reasons he advances for urging upon Congress the passage of the force bill. The entire paper is the production of a partisan and not that of a patriot or a president. Read between the lines it is simply an appeal to the Red gang in the House and the Shermanites and Hoars and Chandlers in the Senate to do everything in their power, by the means of corrupt legislation, to perpetuate the waning power of the Republican party and to breathe some vitality into its fast stiffening—and aching—carcass.

The men who have been organizing twenty-five of the mower and reaper factories of the country into a huge corporation say that unrestricted competition has reduced prices below a profitable level. This is one of the most significant consolidations of competing capital yet formed. The products of the several factories are mainly protected by patents, and by variety of demand as well as supply. Some farmers prefer a "Wood mower," others a "Buckeye," and so on, and it would seem that under such conditions competition would not be as sharp as in the general line of production. But the men back of this movement—and they represent many, if not most, of the leading reaper and mower factories of the country—say that this is not the case, but that competition is so fierce it must be abated to save them any profits. If that be the case here, there is hardly any line of production where it should not also be the case. What, then, is to become of the principle underlying the present industrial system?

The Philadelphia Times rightly thinks that at this time there is one man who stands preeminent for the Democratic nomination for President, a Democrat of Democrats, and that his full name is Grover Cleveland. In the leading editorial in that paper in its Monday's issue it says:

"If the Democratic National Convention had to meet at this time or at any time in the near future to select a candidate for President it would nominate Grover Cleveland by a practically unanimous vote outside of New York, and it would nominate him quite as enthusiastically and as overwhelmingly if New York were against him as if New York favored him. The swift mutations of American politics might make Mr. Cleveland less available or some other man more available eighteen months hence, but it is not probable.

"It was Grover Cleveland who defined so sharply that none could misunderstand it the issue of oppressive taxation of the people in the interest of monopoly greed, and it was Grover Cleveland who commanded the trust of the people by his implacable hostility to jobbing profligacy.

"The people want tax and tariff reform, they want ballot reform, they want civil service reform, they want honest government, and the New York leaders who now malignantly revile Mr. Cleveland are daily teaching the necessity of his nomination.

"Unless inconceivable changes in the political situation shall occur within the next year Grover Cleveland will be nominated and elected President in 1893, and he will be nominated and elected without even the trouble of an inquiry as to whether New York is for him or against him."

That is a queer provision in the new Constitution of Kentucky, now being framed in Convention, which gives the Governor the right to pardon a criminal either before or after conviction. How any one can become in the eye of the law a criminal before he has been tried and convicted it is hard to see. In most civilized communities a person charged with an offense is held to be innocent until he is proved guilty beyond a reasonable doubt. It is the province of the jury to determine the fact of guilt, and of the Court to interpret the law and apply it to the offense. This Kentucky plan dispenses with Courts and juries, or renders them unnecessary, in that it leaves with the Governor the power to decide in advance of trial whether the accused is deserving of punishment or not, or whether the interests of society will be best served by discharging him without trial.
