This body has been in session for the last two days. The following we give as among the most important items acted upon :

Ordered that Washington Howe, Clerk of Wilmington Township, be required to place the bond of Jos. C. Hill, Township Constable, in the hands of the County Register, and the Register is directed to deposit the same with the Clerk of the Superior Court.

Ordered that the county tax on dividends or profits of banks and brokers shall be five per centum on said dividends or profits, and the Sheriff, after notification of this order, shall proceed to collect the same up to Oct. 1st, 1870, and again on the 1st April, 1871, in accordance with section 18, chap. 229, Laws 1868-'09.

Ordered that the matter of repairing the Poor House, and buildings attached, be referred to the Committee on Poor House, with power to set

LEGISLATIVE SUMMARY.

We make up the following summary of the proceedings of the Legisla ture from the report in the Sentinel : SENATE.

FRIDAY, Dec. 9.

## REPORTS OF COMMITTEE.

Mr. Graham, chairman of the Commit tee on Penal Institutions, through Mr Jones, in accordance with instructions from the Senate, reported a bill authorizing the Treasurer to use \$300,000 of the money now in the Treasury or which may be paid in, known as the special tax fund, in payment of the ordinary expenses of the State government and on appropriations to the Insane Asylum, Institution for the Deaf, Dumb and Blind to the amount of one hundred and fifty thousand dollars, and for the support of convicts and the erection of the Penitentiary to the amount of one hundred and fifty thousand dollars, and the Treasurer is authorized to reimburse the "special tax fund" out of the first moneys which may come into the Treasury of the taxes hereafter to be levied for the purposes above set forth.

Mr. Norment, from the special Commit-tee on Salaries and Fees, reported a bill fixing the per diem and mileage of officers and members of the General Assembly, to wit: President of the Senate and Speaker of the House \$7 per diem ; members \$5 per diem; Principal and Assistant Clerks \$6 per diem; Enrolling and Engrossing Clerks \$5 per diem ; Doorkeepers and assistants \$5 per diem; and 20 cents mileage in addition to the whole.

Mr. Robbins, of Davidson, moved to amend by decreasing all of the amounts fixed in the bill.

The President ruled that only one amendment at the time was in order. Mr. Robbins then mayed to amend by

striking out \$7 per diem for the President and Speaker of the House, and to insert in lieu thereof \$5 per diem. The question was divided and the mo-

tion to strike out \$7 was lost, by a vote of yeas 19, nays 26, and the bill was rejected by a vote yeas 22, nays 23.

THAT A SPECIAL ORDER.

Consideration of the bill relating Municipal Elections, question being a motion of Mr. Graham to reconsider the vote by which the Senate refused to strike out limits and insert 90 days.

After some discussion the motion to re-consider prevailed, yeas 27, nays 14. The motion to strike out and insert pre-

vailed, yeas 27, nays 14, and the bill pass ed its third reading yeas 27, nays 13. By leave the following bills and resolu-

Messrs, French, Gregory, Ashe and Mc-Afee argued in support of the substitute. Mr. Welch could not support the bill or substitute, unless a Proviso was adopted, providing that nothing in the act should prevent the Legislature from providing for representation in the Road in accordance with the interest which the State might have.

Mr. Sparrow followed in support of the bill. On motion, the further consideration of

the matter was postponed and made special order for Monday at 12 o'clock, and ordered to be printed.




