Weather Report. WAR DEPARTMENT, Office of Chief Signal Officer, Washington, March 20-4:35 P. M.

The following is a synopsis of the weather reports for the past 24 hours ;

reports for the past 24 hours: Clear weather has prevailed on the Gulf and west of the Mississippi. It has gradually clouded up along the Atlantic coast with light rains from Virginia to Connecticut. The high pressure still continues on the coast of Maine, but has diminished rapidly on the mid-Atlan-tic and lower lakes. The largest pressure has moved from Lake Michigan eastward and is now between Lakes Ontario and Huron. The northeasterly gals on Lake Superior has aba-ted. Fresh northwesterly winds prevail there. Brisk southerly winds are reported on Lakes Ontario and Erie, and brisk westerly winds on Lake Michigan. Lake Michigan.

Threatening weather with fresh and brisk winds are indicated for Tuesday north and cast of Virginia, and cloudy weather on the south Atlantic and the Guif and upper lakes.






