

Several changes, to go into effect on the isl of July, have been made in the printing and distributing of stamped envelopes by the Postoffice Department. Hereafter special devices and the address of correspondents will not be printed under any circumstances whatever. The printing of cards and requests across the end has been discontinued. In future they will be printed on the upper left hand corner only. Business avocations or employments will be excluded from cards and requests. The name of the writer only should be given, without any reference to his occupation. Cards and requests must be limited to the following matter, or so much therof as may be desired. to wit: 1st. Thename of the writer, whether individual, firm, company or corporation, 2nd. The postoffice address, including number and name of street name of city or town, county and State. 3rd. A request to return if not delivered within a given or blank number of days. The occupation of the writer, as "Merchant," "claim agent," "attorney at law," "dealer in dry goods, groceries," &c., &c., must be rigidly excluded. This prohib

ition does not, however, apply to cases in which an employment may be indicated by a corporate name, or by the usual style of an individual firm, or association, as "Baltimore and Ohio Railroad." "Treasurer's Office, Wilmington Water Works," "John Smith's Banking House," "Washington Lime and Cement Co.," which may be printed as the name of the writer; but the name of any individual will not be printed apart from and in additon to such recognized business appellation. The restrictions have reference to the Department only, and does not of course prevent parties from having stamped or other envelopes purchased by them printed in any manner they may desire, at their own expense. Look Out for Them.

The Chesterfield Democrat, published Cheraw, S. C., learns that a few days ago two strange negro men appeared at a store at a place called Hamburg, in Marlboro county, between Gardner's Bluff and Bennettsville, and commenced trading. When they settled for what they had purchased one of them pro duced a large roll of greenbacks, supposed to be several hundred dollars. The other immediately gave him a nudge, when they went to the door and heid a conversation. They came back to the counter, having concealed the roll of greenbacks, and paid for the articles bought from a roll of small bills, produced from the vest pocket. On inquiring they said they were from the upper part of Chesterfield county, near White Store, and were going to Wilmington. The storekeeper suspected that they were part of the gang that murdered Mr. Redfearn at White's Store some weeks ago and inquired if they had heard of that gentleman's murder. They said they had not, and left, going in the direction of Wilmington. As only about \$500 has been recovered of the \$2,000 or \$3,000 supposed to have been in the possession of Mr. Redfearn at the time of his murder, some suppose that these men were of the party who committed the deed.

A Crasy Woman.

A crazy mulatto woman, by the name of Emeline Sadberry, was picked up on the streets yesterday and placed in the Guard House. She appears to be perfectly harmless, her case presenting one of those singular phases of insanity which is just the opposite extreme to that which characterizes a large number of this unfortunate class. Since she has been in the Guard House she has maintained a stolid silence, all the efforts of those who have visited her having failed in getting her to speak a word or pay the slightest attention to their questions. Upon being locked up she took a position in the middle of the floor, and she seems to have come to the determination to "fight it out on that line," as, if we may except an occasional swaying of the body, she had steadily maintained her ground, with a slight inclination of the head and her arms hanging apparently helplessly by her side, up to a l.te hour yesterday afternoon. 
