was found that he was so easily satisfied, and they telegraphed to the Trearury Department to see if such a bond had been issued, giving a description of the same, and received the reply that there had been such a bond issued, but that it had been caveated. In other words nobody was authorized to sell the bond except the person in whose favor it was made.

Previous to telegraphing, however, the officers of the Bank carefully examined the bond and came to the conclusion that it was, in their opinion, a counterfeit. Information was thereupon, given to U. S. Commissioner McQuigg, who issued a warrant for Keeler's arrest, which was placed in the hands of U. S. Deputy Marshall Neff, who discharged his unpleasant duty and the young man was lodged in jail to await an investigation. *

At 41 o'clock P. M., yesterday, he was arraigned before Commissioner McQuigg. Messrs. Larkins and Bowden of the 1st National Bank, and Capt. I. B. 


