HOUSE OF REPRESENTATIVES. THURSDAY, Dec. 7. House called to order at the usual hour. A message was received from the Governor transmitting the report of Col. S. Med. Tate, President of the Western Division of the W. N. C. R. R. The report was referred to the committee on internal improvements.

The Senate resolution authorizing the Attorney General to sue out a writ of habeas corpus for Allen Beattie, of this State, who was recently arrested in Cleveland county by the military authorities and carried to South Carolina, was taken up and passed its second reading.

On motion of Mr. Sparrow the rules were suspended and the resolution put on its third reading. Mr. Houston took the floor in denunciation of the outrage of Mr. Beattie's unlawful arrest, and characterized the Governor's omission, in his message, to mention this matter as exceedingly strange and unpardonable, &c.

The bill to incorporate Warren Lodge, F. and A. M., Kenansville, was taken up and passed its several readings. The bill concerning Constables was taken up and passed its second reading by a vote of yeas 64, nays 20.

On motion of Mr. Gregory, the rules were suspended and the resolution, introduced by Mr. Young of Yancey, adding to the rules of the House an additional rule which provides for the expulsion of any member who shall wilfully present to the House any paper purporting to be a petition, memorial, &c., insufling to its dignity, was taken up and, on motion of Mr. Gregory, was referred to the Judiciary Committee.
