An Alleged Horse Thief Arrested and Committed to Jail.

en was arrested in this city on Monday evening on the serious charge of having stolen a horse. It is alleged that on Sunday night last he went to the house of a man named Kelley, at Harrell's Store, in what was formerly known as Franklin township; New Hanover county, but which has recently been trans ferred to Sampson county, and that sometime during the night he took the horse out of the stable and brought him to this city. During Monday he offered to dispose of the animal to several of our citizens, stating that he had cost him \$60 and that he would be willing to sell him for \$75. Finally he struck a bargain with Messrs. Southerland & Steagall, who had no suspicion that Bowen came by the horse by other than fair means. In the afternoon, however, Kelley made his appearance and having notified the police Bowen was soon after arrested and lodged in the Guard House. In the meantime a warrant was issued by Justice Woodford and yesterday morning Bowen was ca ried before that magistrate, who committed him to jail to await a requisition from the authorities of Sampson. In the meantime, however, Messrs. Southerland & Steagall, not knowing the real state of the case, had swapped the borse with a drover, who left this city yesterday morning for with him; but a telegram was sent after him and the animal will doubtless be returned.
