Fatal Accident.

He then started to walk some, as it is supposed, but finally succumbed to the number and power of his potations and lay down on the track and went to sleep. Capt. Morrison brought the body down to Moss Neck yesterday, where it was delivered to his brother and other relatives. Deceased was about 22 years of age.

report. It is as follows : PRESIDENT'S ANNUAL REPORT.

LADIES : It is with feelings of profound satisfaction that I announce to you to day the attainment of an object so ardently desired by us, and for which we have labored so cheerfully during the past six years, namely : the erection in Oakdale Cemetery of a suitable monument to the Confederate dead. We have redeemed the promise made years ago, " that we would rear a monument to which Wilmington might point with a pride commensurate with the patriotism which impelled her to send forth her bravest and best beloved sons, to do battle for a just cause;" many of whom returned only to repose beneath the peaceful shades of our "silent city of the dead." That our ef-forts in this praiseworthy design were not crowned with success at an earlier period is due, mainly, to the impoverished condition in which our people were left at the close of the war, and not, we would fain believe, to any - Wm. McLaurin, a colored Justice of the Peace, is officiating in the trial of city cases And while our sister Associations, in various parts of the State, are engaged in the same good work, and other monuments are in process of construction, we are glad to believe that our own will be the first Confederate monument completed in North Carolins.

In selecting a design for the monument, we sought to combine simplicity and durability with harmonious proportions and chaste ele-gance, rather than lofty dimensions with elaborate embellishments-indeed, the pancity of our finances would have precluded the latter --and have endeavored to preserve it, as far as practicable, from everything like individu-ality, as is shown in its dedication to the Confederate Dead, of every section of our beloved South, whether unknown or identified-

wherever the fortunes of war may have cast their honored remains. The Pedestal is constructed of North Carolina granite, which is pronounced by competent judges to be of the finest quality. It is surmounted by the statue of a Confederate Soldier, cast in the purest bronze, and we are told by those who ought to know, that it will compare favorably with any similar work of artin the country. It certainly reflects great credit upon; the taste of the Artist who designed it, as well as the skill of the Artisars in his employ.

The gentleman who was commissioned by the ladies to centract for the monument and superintend its erection is entitled to the thanks of the Association for his very efficient services. To his untiring energy and practical aid we are indebted for the completion of he monument during the present year. A






