THE PENITENTIARY REPORT.

From the "Report of the Board of Directors, &c., of the Penitentiary of North Carolina" we glean these facts: Number of persons confined Nov. 1, 72, 366, classified as follows-white males, 59; white females 1; colored males, 291; colored females, 15. Of the 493 confined during the year, 318 were sentenced for larceny, 32 for burglary, 17 for horsestealing, 16 formanslaughter, 14 for murder, 14 for arson, 12 for robbery, 14 for rape and attempt to commit same. These figures show that men's unhallowed greed of gain leads them to commit more crimes than any other cause.

As to counties the convicts are distributed: 32 from Wake, 21 from Craven, 18 from New Hanover, 16 from Beaufort, etc., showing a preponderance of crime in the great negro counties.

There are under 20 years of age 112 persons confined, which shows the necessity of a better moral regimen for our youth.

From the report of the assistant architect, we learn that the total amount of cash expended in the building department during the year ending November 1, 1872, was \$154,-205.371; convict labor amounted to 848,115,60,

From the Physician's report we learn that the mortuary ratio for the year was as 29 to 4, partly attributable to the numerical excess of the colored element, and partly to the imprudence and recklessness of the

We have not heretofore taken the slightest no-tice of these evil-disposed creatures, and we only do so now to prevent fair-minded, honorable persons from being deceived, and lest our continued silence be construed into an admission of the truth of these infamous falsehoods, * * * therefore earnestly invite the General Assembly by such mode as they deem proper to make an investiga-tion of the management of the penitentiary and the disbursement of the public funds.
