We really cannot see how any member of the Legislature can hesitate as to his choice between the two bills. Col. Bennett's bill guarantees the completion of about 74 miles of railway; and this will give an unbroken and unfettered connection between Wilmington and the West, Col. Morehead's bill only proposes to build about 40 miles of railway, and, if built, we have every reason to believe that the Southern Railway Security Company will be the owners or congine. trollers of the line.

We beg the Legislature of North Carolina to pass no bill that will tighten the ligatures with which the Southern Security Company have already bound us. Rather give us an opportunity to loosen the fetters, even if we cannot break them. That corporation, under the shrewd manipulation of Tom Scott, has already secured the control of nearly ail the railways in the State. They have the North Carolina road, and the Richmond and Danville road with its terminus at Greensboro. What, then, would add more to their joy than to seize the opportunity that would be offered them by the passage of the Morehead bill ? This would enable them to extend their line from Greensboro to Fayetteville, and the latter town would be robbed of her legitimate trade within gunshot of her corporate limits.

Let Col. Bennet's bill pass, however, with the Favetteville-Lumberion proviso, and the Tom Scott cormorants will be driven from the field in diamay; for we feel assured that parties will be found to complete the whole line within a reasonable time, and our Western friends will thus have a choice of markets between Wilmington and Fayetteville,

It is evident that the Western Railroad Company cannot complete their goad without aid from others; and the State's interest in that corporation is almost valueless. Certainly, this seems to be the impression at Raleigh; and if any transfer of that


