Local Notes. The Wilsons predict that Beat Rice will be the slogan in the Third Ward to-night.

A ball for the benefit of the Wilmington Rifle Guards, a colored organization, took place at the City Hall last night.

Steve Lowrey, the only remaining member of the famous Robeson outlaws, made a narrow escape from capture a few nights since.

James McQueen, more familiarly known as Donahoe, was in the city yesterday. He had his gun strapped to his back and excited no little interest.

There is to be a public examination of the city Free School on Seventh street between Ann and Nun, on Thursday and Friday mornings of this week.

The Knight of the Thundering Lung will raise his mighty voice against the Canaday pony in the First Ward to-night, and great will be the terror thereat.

There were 987 bales of cotton exported from Wilmington during the past week, of which 170 bales went to Baltimore, 824 to Philadelphia and 493 to New York.

A fire at Fayetteville, Saturday, destroyed the dwelling of an old colored woman known as "Becky Ben," and one or two others in rear of the old Dobbin House.

It is estimated that nine hundred of the fire-iries will rise to "pints of order" at the Ward meetings to-night. The lucky ones will be those who are sharp enough to see the "pints."

A colored Ethiopian Burlesque Company, which has recently been organized in this city, will give a concert on Wednesday and Thursday nights for the benefit of the Cape Fear S. F. E. Company.

There was an old man in the city yesterday, giving his name as Wm. Whitaker, who says he fought under Wellington in the battle of Waterloo. He was on his way from Charleston to Richmond.

Dr. Frank Hines, who lately graduated from the Hannamale Medical College, and who is now on a visit to his brother, Maj. J. S. Hines, of this county, will locate in Wilmington for the purpose of practicing his profession.

As we have had occasion to refer to a broken place in the pavement on the North side of Market, between Front and Second streets, we will now state that we learn the flagstone has been ordered to make a new pavement at that point.

Several of the small India rubber balloons which are being peddled around the city were turned adrift yesterday and floated off heavenward until they were lost to sight.

BOARD OF ALDERMEN.

Extracts from the Proceedings.

The Board met in regular semi-monthly session last night.

The proposition of Alderman Sampson to make Dawson street passable from Front to Second street, and also Water street from Front street to the river, by cutting away an unsightly hill or battery and conveying the dirt to Dawson street, was recommended by the Committee on Streets and Wharves, to which it had been referred, and confirmed by the Board.

The Committee to whom was referred the matter of Policeman Walcott reported that they had examined into his conduct and find that his course in beating a drunken man recently arrested by him was unjustifiable. The evidence produced going to prove that the man could have been carried to the Guard House without the use of the club. Report confirmed.

Gas lamps were ordered on the Southeast corner of Fourth and Campbell streets, Northwest corner of Tenth and Market, Southeast corner of Eleventh and Market, Northeast corner of Twelfth and Market, and Southwest corner of Sixth and Church streets.

Permission was granted H. H. Munson, John F. Stalter, Charles A. Price and D. A. Smith to erect frame buildings on their premises.

Petition of J. N. Hinton for repair of sidewalk near his school house on Fifth, between Ann and Nun streets. Committee on Streets and Wharves.

Petition of Jno. D. Love for refunding taxes paid by him on stock of books, &c., was referred to the City Attorney for his opinion.

Petition of sundry citizens for a gas lamp on the Southwest corner of Second and Princess streets, was referred to the Committee on Streets and Wharves.

Petition of Robert Henning and others in regard to sawdusting Castle street to its connection with the contemplated road to the Sound, was referred to the Committee on Streets and Wharves with instructions to report at next meeting.

Petition of B. F. Mitchell & Son for permission to erect a board awning in front of their store, was referred to the Committee on Streets and Wharves.

A communication from Rev. A. H. B. Blake, Superintendent of City Schools, inviting the Mayor and Board of Aldermen to attend the annual examination of Wilkinton School on Thursday and Friday next, was received and read.

It was resolved that the Sheriff of New Hanover county be requested to instruct the jury in assessing the damage and benefits arising from the opening of Nutt street, for the present their assessment shall not extend beyond Brunswick street.

Alderman Sampson offered the following, which was adopted: Resolved, That the thanks of this Board are hereby tendered to Mr. Owen Bureney for his efficient services rendered while an Alderman of this city.

William Daniels, colored, was granted a recommendation for a license to retail spirituous liquors.

A communication from H. Nutt in reference to damage to his fence and sidewalk, by fire companies on the night of the 11th inst., was received and the City Marshal directed to notify the several companies.

Petition of Howard Relief Fire Engine Company No. 1, for a horse carriage, was granted, provided the city is put to no expense for furnishing or providing for horse or harness.

The ordinance concerning the construction of new sidewalks in certain localities was amended as follows: On Front, from Mulberry to Orange, instead of from Red Cross to Castle; River to Fifth instead of River to Ninth, and Nutt to Front instead of Nutt to Second.

Various Committees were granted further time to report.

The Board then adjourned.

The Anniversary Celebration of St. George's and St. Andrew's Society.

The third anniversary celebration of this association was given last evening under circumstances of the most gratifying character. The members of the Society with invited guests, assembled at Harry Webb's saloon about 8 o'clock, and punctually at nine o'clock the expectant company were ushered into the spacious dining-room of the saloon.

Our space will not permit a detailed description of the elegant entertainment provided by Mr. Webb and his competent assistants, Mr. Collins. The viands were varied and of a sumptuous character, and the avidity with which they were consumed by the assembled company well attested the skill employed in their preparation.

When the fragments of the sumptuous feast had been removed, the attention of the company was demanded by the President, Mr. Sprunt, as he inaugurated the "feast of reason and flow of soul."

The first toast, "The Day We Celebrate," was given by the President, and accompanied with a speech of great interest and real eloquence. Mr. Sprunt gave an interesting account of the formation of the Society—the first organization in this country embracing as members representatives of the two nationalities, of which St. George and St. Andrew are the respective patron saints.

After the President's speech an interlude of a few minutes was delightfully passed in listening to the "Fine Old English Gentleman," as given by Mr. Brown.

The second toast, "The Queen" was announced with some appropriate accompanying sentiments by President Sprunt, which were received with hearty evidences of enthusiasm, as was also the third sentiment in honor of the President of the United States.

"England," the fourth regular sentiment was responded to in a handsome manner by Mr. Gillespie. "Scotland" the fifth sentiment in order was responded to by Mr. Colville in a speech which merited the warm reception it met.

Another interval of musical entertainment by Messrs. Brown and Colville was followed by a few humorous remarks from Dr. W. G. Thomas.

The sixth sentiment, "The Land of Our Adoption," was responded to briefly by Sheriff Black.

The "City of Wilmington," seventh in the order of regular toasts, was responded to by Major Engelhard in a few felicitous remarks which met with a cordial reception.

The Press was briefly responded to by Professor Alford.

A short musical entertainment by Mr. Chapman and Major Mann, preceded the sentiment of "The Old Folks at Home," which was responded to by Mr. Alexander in a few pertinent remarks.

A sentiment in honor of the King of Prussia was responded to by Mr. Pechand in terms of grateful acknowledgement for the compliment paid to the man whom "Germans honor above all men."

The "Health of the King of Denmark" responded to briefly by Mr. Heide.

"The Ladies," the last of the regular sentiments, was humorously responded to by Mr. Greene, who made an intellectual effort to provoke a response in behalf of the ladies from "several handsome bachelors" present.

At a quarter past twelve o'clock, after the singing of "Auld Lang Syne," the company dispersed with many friendly assurances and promises of future reunions under the auspices of the hospitable Britons of the Society of St. George and St. Andrew.

An interesting feature of this delightful occasion, necessarily omitted here, were the letters of apology for non-attendance from Col. W. L. Steele, Col. John McRae and Hon. A. M. Waddell.

The Schur, Donna Anna was floated Sunday morning by the Waccamaw Wrecking Company's Steamer Waccamaw and towed up to the city, having sustained loss of rudder and false keel. The Donna Anna was from Charleston, in ballast to this port, and went ashore at Lockwood's Folley during thick weather on the morning of the 20th.

Finding it impossible to save the vessel without immediate assistance, Captain Whaley came to town the same evening and requested aid from the above company. We learn that the immense power of the Waccamaw was brought into full requisition before towing the Schooner off, there having been not enough water at low tide upon the reef which the Schooner had to cross, to float a small boat.

COUNTY COMMISSIONERS.

Extracts from the Proceedings.

The Board met last evening in regular session.

It was ordered that the matter of granting retail liquor licenses be referred to the chairman of the Board with power to act.

Ordered that the Communication from Solicitor Cantwell, in reference to the insufficient bonds of various township officers, as reported by the Grand Jury, be referred to the Finance Committee for investigation.

Sundry applications for retail liquor license were ordered granted, provided that the same are endorsed by the Mayor of the city.

The following report of the Chairman was submitted, adopted by the Board and ordered spread on the minutes: To the Board of County Commissioners.

I beg leave to submit for your consideration the following estimates of money required during the 10 months from March 1st, 1873, to July 1st, 1874, and the probable resources for the same time:

Table with 2 columns: Item and Amount. Includes Ordinary expenses from March 1st, 1873, to July 1st, 1874, \$87,000; Bridges and cartage expenses, \$3,000; Bonds due March 1st, 1874, \$16,900.

Total, \$106,900. Balance in Treasury March 1st, \$12,163; Due from late Sheriff, \$5,029; Leaving to be raised by taxation, \$11,797.

The amount required for support of the County government and the payment of its debt, about to become due, is \$41,100. I recommend, for your consideration, the levy of the following taxes, and estimate the receipts therefrom:

Table with 2 columns: Item and Amount. Includes Real and personal property for Co. expenses, estimated value \$68,000; at 31 cents, \$21,020; Extra tax for payment of debt and interest on same at 6 cts on \$100, \$3,200.

Total, \$24,500. The State and County tax combined will then be: State, on \$100 real and personal property, \$1.00; County, on \$100 real and personal property, .36 2-3; Poll, .05; School tax, on \$100 real and personal property, .8 1-2; Poll, .25; Total, \$2.51.

The recent bill for the establishment of a "House of Correction and Refuge," having passed the General Assembly, it becomes incumbent upon this Board to provide for its establishment. Without knowing how much may be required, or what amount may be profitably employed, I am not prepared to make a recommendation in the matter. It seems to be of great importance that no time be lost in starting it.

Ordered, That the Committee on Finance are requested to obtain the opinion of the Attorney of the County Commissioners upon Section 24, Schedule B of State tax levy, and also Sections 1 and 2, Schedule C of the same, and report to this Board at the next meeting.

The matter of establishing a House of Correction and Refuge in this county, was referred to a special committee, consisting of the Chairman and Commissioners Rice and Morris, to report at next meeting.

The sum of \$50 was appropriated toward the repair of certain bridges on the road between the city and Masonboro Sound.

The Committee on Public Buildings was authorized to procure some suitable place for the keeping of the standard weights and measures of the county at a cost not to exceed \$50 per annum.

The Standard Keeper of the county was instructed to report to the Solicitor all persons who infringe the law against using weights and measures not sealed by the Standard Keeper, after the first day of April, 1873.

WARD MEETINGS THIS EVENING.

This evening, at 8 o'clock, meetings will be held in the various Wards, by the Republican voters of the same, for the purpose of nominating candidates for Aldermen at the ensuing municipal election in May.

It is expected that the meetings will be very exciting ones, as the two aspirants for the Mayoralty will marshal their forces in full strength. The following are the names and classification of the candidates for nomination for Aldermen in their respective Wards, as far as we could gather:

First Ward—John Frangulian and Jacob Wise, Wilson men; Aaron Kellogg and John Lewis, Cassidy men; Henry Brington, independent—supposed to favor Canaday.

Second Ward—March Walker, (Wilson), W. P. Canaday (Canada).

Third Ward—L. E. Rice, (Canada), Allen Evans (Wilson); Daniel Howard, independent—supposed to favor Canaday.

Fourth Ward—R. Cornelius Myers (Canada), James Wilson (Wilson).

Fifth Ward—Jos. C. Hill, Rev. W. H. Banks, Elijah Hewlett, all pronounced to be doubtful.

Richard Holmes and Peter Baker, both colored, were arrested on Saturday night last on the charge of picking the pockets of a white man by the name of James Gruber, who had been in their company. They were taken to the Guard House, where their pockets were searched for the missing money, but only about 60 cents were found on the person of one and about 40 cents on the other. Finally, however, the Janitor, Wm. H. Waddell, took them in hand, when he found \$7 hid in the lining of the coat of one of them and \$5 stowed in the toe of the shoe of the other, which was about the amount claimed to have been lost by Gruber.

Down With the Dust! We learn there is a party in this city who propose to keep the business portions of Front and Market streets thoroughly sprinkled during the coming season provided they can secure enough subscribers among our Merchants and other business men to pay the necessary expenses. They do not expect nor desire to make any money by the scheme, but simply to keep teams and drivers employed during the warm season which would otherwise be the greater part of the time idle. Only a moderate outlay on the part of each one will be necessary, and the benefits and comforts arising from a thorough and systematic street sprinkling will repay them four-fold.

Arrested for Breaking Open a Car and Stealing Baggage. A colored train hand by the name of Josh Sanders was arrested at the depot last night on the charge of breaking open the baggage car on the W. C. & A. R. R. on Monday, the 17th inst., and stealing a quantity of baggage, reference to which has heretofore been made in these columns. He was lodged in jail to await an examination before Justice Woodford.

FRANCOIS. Why is there such great difference in the price of the same quality of peanuts sold in New York and Wilmington? A few days ago a car load of peanuts, shipped by rail from Rocky Point, sold in New York at one dollar and twenty-five cents per bushel, free of frays and all other expenses, except commission for selling, and it was a common article. Our peanut farmers cannot sell this quality of peanuts in Wilmington for more than sixty cents per bushel, and its only cost here is the expense of transport from Rocky Point to Wilmington direct by railroad to New York. The peanut farmers are becoming discouraged and dissatisfied at this disparity of prices between Wilmington and New York. The commission merchants of Wilmington ought to explain, as well as reform and correct errors and abuses. All the farmers ask is justice.

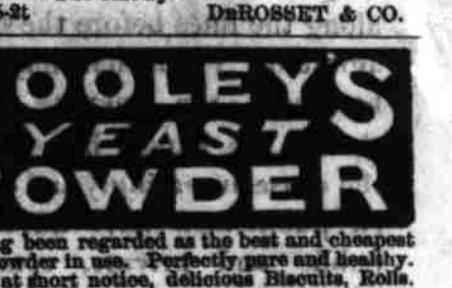
