#### FIELD AND FIRESIDE.

WHOLE CORN FOR FATTENING.

A Rhode Island correspondent of the Boston Journal says that the reathree cents per pound more in market than any others is because these turkeys are fattened, especially in the south part of that State, on hard Indian corn instead of meal, barley, oats or other kinds of food, and because they are picked without being scalded in hot water, and their inwards removed immediately. There is almost as much difference in the bird prepared in this way and one that is fed otherwise and dipped into hot water (to save two minutes labor in picking), and then left to swelter a week with its inwards undrawn, as is the case with most that are brought to the New York, Philadelphia and other markets, as there is between a woodcock and a cow.

So, too, if a hog be fed solely on hard corn and water, its meat will be far superior to that fattened on meal or other soft food as real pure Orange county is to distillery or swill milk. Why are Cincinnati hams so celebrated? Is their superiority owing to the method of curing them solely? By no means, but more to the quality of flesh, which is made entirely from the juices of sweet, hard wild nuts and unground Indian corn.

Take a turkey that has a free, wild range, where grasshoppers are plenty in their season; feed it well with Indian corn and sweet apples only (if the latter are handy) until December; shut it away from food for twentyfour hours, then (handling the sacred thing tenderly) tie a stout cord around its legs and hang to a spike in the beam under your barn; let one artist hold its wings firmly in each hand, while another gently bleeds it at the throat; pick it dry while warm; draw its inwards ditto; let it hang in a cool place for two nights only; roast it before a bright, hot wood fire, turning the spit often to keep the juices from congesting on the surface or elsewhere; set it on the table garnished, if your "fancy or nature will," with woodcock, canvasbacks, rail and ortolan, and if you once get a taste of that turkey you will let every other delicacy before you go to the dogs rather than desecrate your palates with trash so inferior to that king of all game, a corn-fed, dry-dressed, well cooked Rhode Island turkey.

So, too, take a twelve-months' old barrow, place him in a roomy, sunny pen, keep wholly on hard corn and pure water, with occasionally a little salt, until he is fat; kill and dress him nicely, and salt the chines down with plenty of Turk's Island salt within thirty-six hours of his exit, and you will have pork to eat with your capon that is firm, transparent, rosy, sweet and delicate. So again, take the hams of such a hog, cure them well with blown salt and saltpeter, smoke them with clean fresh corncobs and nothing else (letting them cool off nights) until they attain the complexion of a hazelnut, or one of Titian's most characteristic portraits a trifle subdued. Then boil at slowly, and when thoroughly done let it stand a night in the liquor, and you will have the only "thing of beauty" that is worthy to be eaten off the same plate with your Rhode Island phalia, North Carolina, Newbold or Cincinnati bacon.

A New African Expedition. The London Daily Telegraph annonnecs that the proprietors of that paper have united with Mr. James Gordon Bennettin organizing an expedition of African discovery, under command of Mr. Henry M. Stanley. The purpose of the enterprise is to complete the work left unfinished by Dr. Livingstone; to solve, if possible, the remaining problems of the geography of Central Africa; and to investigate and report upon the haunts of the slave-traders.

## Russell on Civil Rights.

Opinion of Judge Russell in the Matter of the Late Theatrical Im-

From The Morning Star of October 24, The following is the decision of Judge Russell in the cases of Hostler, Sampson, Robinson and Price, who sued out peace warrants against Mr. E. J. Pennypacker, Lessee of the Opera House, a week or two since. The circumstances are sufficiently

explained in the document which follows: This is a proceeding before a Justice of the Peace, wherein the defendants were bound in a recognizance to keep the peace upon the complaint of one E. J. Pennypacker. It appears from the evidence that Pennypacker is the preprietor or tenant in possession of a certain public Theatre or Opera House in the city of Wilmington; that defendants, having procured tickets, presented themselves at this Theatre, and attempted to get admission therein; that the prosecutor refused them admittance, upon which they attempted to force their way in; that he forcibly resisted their attempt; that one of them succeeded in getting inside the house, while the others were prevented from entering. On the next day, the prosecutor having heard that defendants had threatened to force their way in the house when opened again for another public entertainment, and having formed and expressed a purpose to prevent them from entering the house, applied to the Mayor of the city for a police force to suppress disturbance and protect him in his possession; and als institu ted this judicial proceeding. That defendants did attempt to enter, after being forbidden by the prosecutor, and that they did present themselves for admittance in a manner that might well have been considered menacing and disorderly, seems to be established by the evidence:-that they cherished a purpose to repeat their attempt and to accomplish it by force, seems to have been honestly believed by the prose-cutor; and this belief is, I think, sustained by all the circumstances. From these facts

it follows that the prosecutor was justified in suing out this process; and the question as to whether he had a right to exclude these parties is not to be considered .--No one is allowed to assert or enforce a mere civil right by resorting to violence.-If one has my property and wrongfully withholds it, I have no right to take it from him forcibly. If one wrongfully obtains possession of the house of another, the owner, although he have an absolute title and an unquestionable right of possession, must not violently seize the premises son Rhode Island turkeys are worth and forcibly eject the possessor. If he does he is answerable to the criminal law, and it will be no defence for him to set up title in himself. This is so even in a case when the party in possession is a mere wrong doer, a trespasser ab initio. An inn keeper or common carrier has no right arbitrarily or capriciously to refuse to entertain or carry a per son. Yet, if they do unlawfully so refuse, it is not for the injured party to take upon himself those powers which belong only to the officers of the law, and thus seek to enforce his rights according to his own construction of them, and by a resort to force not authorized by any legal process. To allow it would be to authorize the commission

of acts inconsistent with the peace of society and subversive of all public order and Enough appeared in the examination of these cases to show that in truth there was a controversy between these parties as to the right of the defendants, who are men of color, to accommodations and privileges in this theatre equal to those enjoyed by other persons. Assuming that this house is a place of entertainment for the general public, that it is licensed by the laws of the State, and that there is nothing in its objects or character which relieves it from those legal rules which apply to the government of all insti-tutions in which the public has an interest and which are established or permitted for the public good-as to all of which there was no evidence

and hence I express no opinion—assuming that this is the fact, I apprehend that the right of these defendants to precisely the same accommodations and the same treatment as other persons, will not be questioned. The pretension that any person or class may be prevented from resorting to a public place whose doors are open to all but them and denied to them only on account of color or race, will not be tolerated by any Court honestly and sincerely desirous of expounding the Con-stitution and laws according to their true intent and meaning. It may be that the manager of this theatre has the right to separate different classes of persons whose close association is not agreeable to each other—always remembering that he must not discriminate against any; but that the accommodations given, the comfort, style, convenience and all other considerations for which the parties pay their money, shall be the same as to all, or so nearly so as to furnish no substantial cause of complaint by any. This opens a wide field of argument into which I have not the time to enter. The defendants, by adopting unlawful means of asserting what they believed to be a right, have rendered themselves amendable to this proceeding. If it was their purpose to test a legal right they ought to have kept inside of the lawnot to have constituted themselves violators of the law, whose protection and assistance they were seeking. This much is said in reference to the rights of the parties lest the decision of this cause shall be misunder-

stood. A court is always sustained in giving expression to an obiter dictum when the pur pose is simply to avoid a misconception of the extent or bearing of its decision. This opinion is formed almost without any opportunity for reflection, without any argument by counsel and without consulting a single authority. Hence I do not ask or expect for it any consideration greater than is usually given by the profession to the ductum of a nisi prius Court rendered in the hours of business and without that deliberative and mature study always given to cases which are to be looked to as authority. I would not have put this opinion in writing but for the apprehension that the ruling would be misunderstood or misrepresented.

It is adjudged that the warrants be dismissed at the cost of the defendants. [In re-publishing the above opinion, we have italicized that portion to which we wish to call special attention.-EDS. STAR.





#### Quarantine Notice.

All vessels with sickness, or having had sickness aboard during the voyage, are required to come to the Station for inspection, regardless of the port from whence they came. Vessels not subject to such regulations will proceed to Wilmington without detention.

Pilots are especially enjoined to make careful en-quiry, and if not satisfied with the statements of the Captain or person in command, or if the vessel is in a filthy condition, they will bring the vessel to the Station for further examination. Pilots wilfully violating the Quarantine laws are subject to forfeiture of their branch; Masters of vessels to a fine of Two Hundred Dollars for every day they violate the Quarantine laws; and all other persons are liable for every offence.
