WILL GENERAL CLINGMAN DO THE STATE A GREAT SERVICE?

The approach of the hundredth year of our State independence and the passage by the late Legislature of a resolution chartering a Historical Society suggest anew the fact that North Carolina is still without a History. We speak deliberately but precisely, meaning that we are minus a great record of the splendid deeds we have achieved as a people. There are books on the subject, some covering particular epochs, some unfinished, other some misshapen, ill-arranged, clumsily written—none up to the requirements of a brave and intelligent though modest and unassuming people. We say the events named suggest anew this fact of a popular want. Time and time again have we alluded to the subject. Indeed, we feared one while we had worn the callous reader's patience threadbare. But we love the old State and her grand traditions, her state history and her present good too well to be a faint-hearted in this endeavor. We shall persist in the good cause until somebody essays the noble task to which he is invited by every consideration of State pride and high personal ambition.

In accordance with this spirit we make a nomination, to which we feel that there will be raised throughout North Carolina and all out among her friends no whisper of objection, but on the contrary a full chorus of cordial and energetic approval. We request that ex-Senator and Gen. Thomas L. Clingman shall devote himself for the necessary time to the composition of an elaborate though not necessarily voluminous "History of North Carolina from the early voyages to the adoption of the Constitution of 1875." Gen. Clingman has the general culture, the practical insight and knowledge, the practical intellect, the rhetorical ability and the judicial spirit requisite for the great work. Besides, he has anational reputation which would give the book a broad introduction. The pains-taking geologist, the liberal scholar, the earnest orator and statesman, above all the proud North Carolinian, T. L. Clingman, is just the man to do the thing up brown. The necessity for the work being done thoroughly, something as a Macaulay, a Stanhope, and a Freeman did for England, is universally conceded. Clingman is yet in the vigor of an elderly prime—if we may be allowed to choose our phrase—and he could accomplish the task if properly sustained by official countenance and aid and by a liberal and enthusiastic public sentiment. Will he undertake it? Can he refuse to do so great a service to the people who have in times past so generously honored him and who still respect and esteem him as one of the first of the sons of the State, if the spontaneous voice of that people shall set him apart as the right man found at last to record the heroic deeds of strife and stake that gild the very tree-tops on our lofty mountains and make immemorial music in the leavy coverts of our lowlands.

ONE LITTLE GRAIN OF GOOD, PERHAPS.

If the Beecher filthiness produces such a reaction towards orthodoxy in religion and morals as the excerpt hereinafter made would seem to hint at as desirable, perhaps after all it may not be regarded by posterity as an unmixt evil. The New York Sun, edited by a scion of the old Puritan race, says: "The revelations of the moral tone of Plymouth Church which this trial is making, are not of a sort to encourage us to believe that the style of Mr. Beecher's preaching and the quality of his teaching are such as to invite their adoption as models by other ministers. The terrible old doctrines are better than his in their effect on men. In fine, we do not think that Brooklyn would be in utter spiritual darkness if Plymouth pulpit should become silent. Yet we acknowledge the truth of whatever within reason may be said of the eloquence and aptness of Mr. Beecher as a platform orator."

THE PRESS AND CONSTRUCTIVE CONTEMPT.

Mr. Wilbur F. Storey, editor of the Chicago Times, has often offended the taste and even the moral sentiment of dissolute Chicago by the indecencies of his sheet, which is a sor-

ret of journalistic Bedouin. But his sentence to imprisonment by a Judge on the charge of constructive contempt seems to have occasioned for him a sympathy to which he could never otherwise have laid claim and which certainly would not have been extended to him under other circumstances. The whole press of the city irrespective of party condemn the sentence as harsh and unjust, and demand that henceforward the judiciary shall better respect the rights of the press, which is the people's bulwark.
