VIEWS OF THE BRITISH "THUNDERER." LONDON, April 10-9 A. M. The Londou Times, reviewing the

text of the German note to Belgium, says: "Our expectations were justified that fuller knowledge of the tenor of the German note would remove the more serious constructions which have been made of it. Germany remonstrates with Belgium, and makes recommendations beyond the bounds of good taste, but puts forth nothing which we are able fairly to call a threat. It is the interest of every free nation to protest against a claim that expressions of sympathy with any cause in a foreign country belong to the order of international wrongs which the State is bound to restrain. The circumstance, that neither party to the dispute has appealed to the powers guaranteeing Belgian independence, also somewhat diminishes the importance of the affair."

The Proposed Presbyterian Confederation.

At the meeting of the committee appointed from most of the leading Presbyterian churches in this country, held in New York on Thursday evening, to take measures for joining" in the proposed Presbyterian confederation in London, in July next, the Rev. Dr. McCosh, of Princeton College, save a brief outline of the objects of the conference. He said that at the present time forty-eight Presbyterian organizations would be represented at the forthcoming meet, ing in London, which comprised no less than twenty thousand congregations, representing England, Scot-Ireland, Australia, Amerland, New South Wales, New ica. Zealand, and many other nationalities. It was necessary that the delegation from America should be well represented, and he had no doubt that it would. Dr. McCosh then read the three several drafts of resolutions or instructions, one of which was proposed to be agreed upon and laid before the conference in London. This draft constitution would be considered by the proposed confederation, and by them confirmed. The drafts were prepared by Dr. McCosh, Dr. Hatfield and Dr. Matthews. A number of suggestions were given out, one of the principal ones being that the confederation did not propose to form or adopt a new confession of faith, but require every church proposing to join it to submit its creed, and will admit only the churches whose creed is in conformity with the consensus of the Reformed Church.




- There will be a meeting of the ownship committees in Iredell on the 31st to make up the quota of that county for the Centennial fund, &c.

mar 30-tf At Greensboro last week Judge Dick declined to express any opinion as to the constitutionality of the Civil Rights bill -believing such a course premature-but expressed a concurrence in the construction of the law adopted by the Ohio courts. He holds to the opinion that the act gives the colored man no rights in this State that he did not possess under the old statute laws; with the exception of trial in the Federal Courts, if he so elect. He held that the law only applied to railroads, steamboats, hotels and theatres, and did not necessarily place negroes and whites together in these, but only entitled the colored man to the same accommodation as the white man if he can afford it. Separate apartments and coaches could be designated for each race, and neither could infringe upon the rights of the other.
